EDUCATION, ENGLAND AND WALES

The Direct Grant Schools (Amendment) Regulations 1968.

Made - - - 19th July 1968
Laid before Parliament 25th July 1968

Coming into Operation 1st August 1968

The Secretary of State for Education and Science, in exercise of the powers conferred upon him by section 100 of the Education Act 1944(a) as amended by the Secretary of State for Education and Science Order 1964(b), hereby makes the following regulations:—

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Direct Grant Schools (Amendment) Regulations 1968 and shall come into operation on 1st August 1968.
- (2) The Interpretation Act 1889(c) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Definition

2. In these regulations the expression "the principal regulations" means the Direct Grant Schools Regulations 1959(d) as amended (e).

Capitation grant

3. Capitation grant shall be payable to the proprietors of a grammar school under regulation 4(1)(a) of the principal regulations at a rate not exceeding £32 and accordingly for the reference in that paragraph to £52 there shall be substituted a reference to £32.

Provision of milk

- 4. Regulation 13 of the principal regulations shall cease to have effect in so far as it requires the proprietors of a grammar school to provide for the supply of milk to day-pupils and accordingly there shall be omitted—
 - (a) in paragraph (1)(b) of that regulation the words "of milk to drink and"; and
 - (b) in paragraph (2) of the regulation the words "or for the milk supplied to day-pupils".

Dismissal and exclusion of teachers

5. For regulations 23 and 24 of the principal regulations there shall be substituted—

"Restriction on employment of teachers

23. A person who is on grounds of misconduct or conviction of a criminal offence determined by the Secretary of State to be unsuitable for employment as a teacher or suitable for employment as such only to a limited extent, shall not be employed as a teacher or, as the case may be, shall be employed as such only to the extent determined by the Secretary of State.

Reporting of termination of employment of teachers

24. If the engagement of a teacher is terminated whether by dismissal or resignation on account of misconduct or conviction of a criminal offence, the facts shall be reported to the Secretary of State."

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These regulations amend the existing provisions relating to the payment of capitation grant to, and the provision of milk in, direct grant grammar schools and to the dismissal and exclusion of teachers from direct grant schools generally.
