HIRE PURCHASE
**The Hire-Purchase and Credit Sale Agreements (Control)
 (Amendment No. 10) Order 1968**

<i>Made - - - -</i>	23rd October 1968
<i>Laid before Parliament</i>	24th October 1968

The Board of Trade, in pursuance of the powers conferred upon them by sections 1 and 22(3) of the Emergency Laws (Re-enactments and Repeals) Act 1964(a) hereby order as follows:—

1. The Hire-Purchase and Credit Sale Agreements (Control) Order 1964(b), as amended(c), shall have effect, in relation to any hire-purchase or credit sale agreement entered into on or after 25th October 1968, subject to the amendment that in Part I of Schedule 1 for item 20 there shall be substituted the following:—

“20(a) Mechanically propelled road vehicles constructed or adapted for the carriage of passengers or goods, and parts thereof (including chassis); excluding vehicles constructed to carry not less than twelve passengers and excluding vehicles constructed or adapted for the carriage of goods other than vehicles having a weight unladen calculated in accordance with section 255 of the Road Traffic Act 1960(d) of less than 40 cwt. and having to the rear of the driver's seat roofed accommodation which is fitted with side windows or which is constructed or adapted for the fitting of side windows—

(i) in the case of vehicles having more than three wheels	33½	27
(ii) in the case of vehicles having less than four wheels	25	36
(b) Sidecars, and auxiliary units designed or adapted for the propulsion of bicycles and tricycles ...	25	36”.

2.—(1) Article 8 of the Hire-Purchase and Credit Sale Agreements (Control) Order 1964 is hereby revoked.

(2) This Order may be cited as the Hire-Purchase and Credit Sale Agreements (Control) (Amendment No. 10) Order 1968 and shall come into operation on 25th October 1968.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the Hire-Purchase and Credit Sale Agreements (Control) Order 1964, as amended. The Order no longer applies to the disposal under a hire-purchase or credit sale agreement or to the possession by a hirer or purchaser of a goods vehicle other than one weighing less than 40 cwt. unladen which has or is designed for the fitting of rear side windows. The exemption in favour of a hirer or purchaser having a carrier's licence under the Road Traffic Act 1960 is abolished.
