## SEA FISHERIES

**The Salmon and Migratory Trout (Drift-net Fishing)  
Restrictions on Landing (Extension) Order 1968**

<i>Laid before Parliament</i>		18th December 1968
<i>Coming into Operation</i>		15th February 1969

The Minister of Agriculture, Fisheries and Food, and the Secretaries of State for Scotland and the Home Department (being the Secretaries of State concerned with the sea-fishing industry in Scotland and Northern Ireland respectively) in exercise of the powers conferred on them by section 6 of the Sea Fish (Conservation) Act 1967<sup>(a)</sup> and of all other powers enabling them in that behalf, after consultation with the Board of Trade hereby make the following order :—

*Citation and Commencement*

1. This order may be cited as the Salmon and Migratory Trout (Drift-net Fishing) Restrictions on Landing (Extension) Order 1968 and shall come into operation on 15th February 1969.

*Interpretation*

2.—(1) In this order—

“the principal order” means the Salmon and Migratory Trout (Drift-net Fishing) Restrictions on Landing Order 1962<sup>(b)</sup> as amended (c).

(2) The Interpretation Act 1889<sup>(d)</sup> shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

*Extension of Period*

3. Article 3 of the principal order shall be read and construed as if for the date 15th February 1969 there were substituted the date 15th February 1971.

#### EXPLANATORY NOTE

*(This Note is not part of the Order.)*

The operation of the Salmon and Migratory Trout (Drift-net Fishing) Restrictions on Landing Order 1962 (which prohibits the landing anywhere in Great Britain of salmon or migratory trout caught by drift-net in specified waters around Great Britain except that such landings may be legally effected if the catching of the fish off the coasts of England and Wales has been authorised by a River Authority licence or in waters outside territorial waters adjacent to England and Wales by a licence issued by the Minister of Agriculture, Fisheries and Food) is extended for two years from 15th February 1969.
