# The Justices of the Peace Act 1968 (Commencement No. 1) Order 1968

At the Court at Buckingham Palace, the 20th day of December 1968

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 7 of the Justices of the Peace Act 1968(a) and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1.—(1) Subject to paragraph 2, the provisions of section 1, other than the words from "but" to the end of subsection (5) and subsection (8), of, and of Schedule 1 to, the Act shall come into operation on 1st February 1969:

Provided that any person who is on that date mayor of any borough (including a borough included in a rural district), chairman of the Greater London Council or chairman of a county council or district council (within the meaning of the Local Government Act 1933(b), shall continue to be a Justice of the Peace by virtue of that office until the expiration of his current term of office.

(2) So much of Part II of Schedule 5 to the Act as is set out in the Schedule to this Order shall come into operation on 1st February 1969.

2. Paragraph 9 of Schedule 3 to the Act, and so much of section 1(2) of the Act as relates to that paragraph, shall come into operation on 1st February 1969, but otherwise this Order shall not apply in relation to the City of London.

3. This Order may be cited as the Justices of the Peace Act 1968 (Commencement No. 1) Order 1968, and shall come into operation on 1st February 1969.

### EXPLANATORY NOTE

#### (This Note is not part of the Order.)

The effect of section 1 of the Justices of the Peace Act 1968 is that a person shall no longer be a Justice of the Peace by virtue of his holding some other office. This Order brings that provision into force, but existing heads of local authorities will continue to be Justices by virtue of those offices until the end of their current terms of office.

The Order does not apply to the City of London, in respect of which a number of arrangements have to be made before the provisions of the Act can be brought into effect there, except to enable a Commission of the Peace for the City to be issued.
