MEAT AND LIVESTOCK COMMISSION

**The Livestock and Livestock Products Industries
(Payments for Scientific Research) Order 1968***Laid before Parliament in draft**Made* - - - 19th December 1968*Coming into Operation* 20th December 1968

The Minister of Agriculture, Fisheries and Food and the Secretary of State concerned with agriculture in Scotland, acting jointly in exercise of the powers conferred on them by section 16 of the Agriculture Act 1967(a) and of all other powers enabling them in that behalf, hereby make the following order a draft whereof has been laid before Parliament and approved by resolution of each House of Parliament:—

1.—(1) This order may be cited as the Livestock and Livestock Products Industries (Payments for Scientific Research) Order 1968, and shall come into operation on the day immediately following the day on which it is made.

(2) The Interpretation Act 1889(b) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

2. For the purpose of providing funds to be applied for the purpose of scientific research which is connected with the livestock industry and the livestock products industry and which is to be carried out by the Agricultural Research Council, the Meat and Livestock Commission (established under Part I of the Agriculture Act 1967) shall make payments as follows:—

- (a) a sum of £98,000 on or before the 31st March 1969;
- (b) a sum of £197,000 during the twelve months ending with the 31st March 1970;
- (c) a sum of £197,000 during the twelve months ending with the 31st March 1971; and
- (d) a sum of £197,000 during the twelve months ending with the 31st March 1972.

3. All sums to be paid by the Meat and Livestock Commission in accordance with the foregoing provisions of this order shall be paid by them into the Agricultural Research Council Deposit Account, being an account opened by Her Majesty's Paymaster General, such sums to be applied and dealt with by

the Agricultural Research Council for the purpose of scientific research to be carried out by them in connection with the livestock industry and the livestock products industry.
