The National Insurance (Industrial Injuries) (Colliery Workers Supplementary Scheme) Amendment (No. 2) Order 1969*Laid before Parliament in draft**Made - - - 20th November 1969**Coming into operation 2nd December 1969*

Whereas the National Committee for the time being constituted in accordance with the Supplementary Scheme set out in Schedule 1 to the National Insurance (Industrial Injuries) (Colliery Workers Supplementary Scheme) Amendment and Consolidation Order 1963(a) as subsequently varied and amended(b) is the body charged with the administration of that Scheme and has requested the Secretary of State to vary and amend the provisions of the said Supplementary Scheme in manner set out in the following Order:—

Now, therefore, the Secretary of State, in exercise of his powers under section 47(1)(a)(ii) of the National Insurance Act 1965(c) as applied by section 82(2) of the National Insurance (Industrial Injuries) Act 1965(d) and of all other powers enabling him in that behalf, hereby makes the following Order, a draft of which has been laid before Parliament and has been approved by resolution of each House of Parliament:—

Citation, commencement and interpretation

1.—(1) This Order, which may be cited as the National Insurance (Industrial Injuries) (Colliery Workers Supplementary Scheme) Amendment (No. 2) Order 1969, shall come into operation on 2nd December 1969.

(2) In this Order “the Scheme” means the Supplementary Scheme set out in Schedule 1 to the National Insurance (Industrial Injuries) (Colliery Workers Supplementary Scheme) Amendment and Consolidation Order 1963 as varied and amended.

Amendment of Article 12 of the Scheme

2.—(1) In paragraph (3) of Article 12 of the Scheme for the words “or any other Act or Regulations, increasing such rate or amount, which may be passed or made after 3rd June 1969 and come into force or operation before 3rd December 1969”, there shall be substituted the words “or any subsequent Act or Regulations increasing such rate or amount”.

(2) In paragraph (4)(a) of Article 12 of the Scheme for the date "2nd December 1969" there shall be substituted the date "2nd June 1970".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the provisions of the National Insurance (Industrial Injuries) Colliery Workers Supplementary Scheme by extending until 2nd June 1970 the period during which the rates of certain supplementary benefits that are calculated by reference to benefits payable under the National Insurance (Industrial Injuries) Act 1965 are not affected by any increase in such benefits payable under the said Act under or by virtue of the National Insurance Act 1967 or any subsequent legislation.
