The Savings Banks (Fees) (Amendment) Warrant 1969

The Treasury, in exercise of the powers conferred on them by section 9 of the Post Office Savings Bank Act 1954(a), section 88 of the Trustee Savings Banks Act 1969(b), and the said section 9 as applied by Regulation 27(4) of the Savings Certificates Regulations 1933(c) and Regulation 18(4) of the Premium Savings Bonds Regulations 1956(d), and of all other powers enabling them in that behalf, hereby direct as follows:—

1. This Warrant may be cited as the Savings Banks (Fees) (Amendment) Warrant 1969, and shall come into operation on 1st January 1970.

2. The Interpretation Act 1889(e) shall apply for the interpretation of this Warrant as it applies for the interpretation of an Act of Parliament.

3.—(1) The Treasury Warrant dated 9th April 1921(f), as amended (g), fixing certain fees of the Registrar of Friendly Societies in relation to savings banks and savings certificates shall have effect as if:—

- (a) in table II in article 1 thereof (as substituted by the Savings Bank (Fees) (Amendment) Warrant 1953(h)), in the item specifying the fees for an award, order or determination where the savings bank deposit does not exceed £10, for the figures “2s. 6d.” there were substituted the figures “3s. 0d.”;
- (b) in table III in article 1 thereof (as substituted by the said Warrant of 1953), in the item specifying the fees for an award where the value of the savings certificates does not exceed £10, for the figures “2s. 6d.” there were substituted the figures “3s. 0d.”.

EXPLANATORY NOTE

(This Note is not part of the Warrant.)

This Warrant alters from 2s. 6d. to 3s. 0d. the fees in certain cases for awards made by the Registrar of Friendly Societies in respect of disputes relating to savings bank deposits, savings certificates and premium savings bonds. The fees in question were fixed in relation to savings bank deposits and savings certificates by the Savings Bank (Fees) (Amendment) Warrant 1953, and in relation to premium savings bonds by the Premium Savings Bonds (Fees) Warrant 1959.
