ROAD TRAFFIC

The Public Service Vehicles (Licences and Certificates) (Amendment) Regulations 1969

Made - - - 10th January 1969
Laid before Parliament 20th January 1969
Coming into Operation 1st February 1969

The Minister of Transport in exercise of his powers under sections 159 and 160 of the Road Traffic Act 1960(a), and section 30(8) of the Transport Act 1968(b) and of all other powers him enabling in that behalf, and after consultation with representative organisations in accordance with the provisions of section 260(2) of the said Act of 1960, hereby makes the following Regulations:—

- 1.—(1) These Regulations shall come into operation on the 1st February 1969 and may be cited as the Public Service Vehicles (Licences and Certificates) (Amendment) Regulations 1969.
- (2) The Interpretation Act 1889(c) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.
- 2. The Public Service Vehicles (Licences and Certificates) Regulations 1952(d), as amended (e) shall have effect as though—
 - (1) in Regulation 10(1) and (2), for the figure "2s. 6d." there were substituted the figure "5s.";
 - (2) for paragraph (1) of Regulation 17 there were substituted the following paragraph:—
 - "(1) Subject to paragraph (2) of this Regulation the fee for a licence shall be £12 10s. in respect of each vehicle licensed.";
 - (3) in Regulation 24, for the figure "£5 10s." there were substituted the figure "£6 10s.";
 - (4) in Regulation 41, for the words "one shilling" there were substituted the figure "2s. 6d.";
 - (5) after Regulation 48, there were added the following new Part:

"PART VIII.—PERMITS

Interpretation of Part VIII

49. In this Part of these Regulations "permit" means a permit under section 30 of the Transport Act 1968.

Fees

- 50. The fee for a permit shall be £1 for each year or part of a year for which it is expressed to have effect.
- 51. The fee for a copy of a permit, marked as a duplicate, shall be 5s. ".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Public Service Vehicles (Licences and Certificates) Regulations 1952 so as to—

- (i) increase the fee for a public service vehicle licence from £8 10s. to £12 10s. (Regulation 2(2)),
- (ii) increase the fee for a certificate of fitness from £5 10s. to £6 10s. (Regulation 2(3)),
- (iii) increase the fee for a duplicate copy of a public service vehicle licence, a road service licence or a certificate of fitness from 2s. 6d. to 5s. (Regulation 2(1)).
- (iv) fix fees of £1 per annum for a permit under section 30 of the Transport Act 1968 and 5s. for a duplicate copy thereof (Regulation 2(5)), and
- (v) increase the maximum price of copies of the Traffic Commissioners' publication "Notices and Proceedings" from 1s. to 2s. 6d. (Regulation 2(4)).
