**The Grant-Aided Secondary Schools (Scotland)
Grant (Amendment) Regulations 1969**

In exercise of the powers conferred upon me by sections 75(3) and (4)(e) and 76(1) of the Education (Scotland) Act 1962(a), and of all other powers enabling me in that behalf, and after causing a draft of the regulations to be published and sending a copy thereof to every education authority and having regard to the representations made in accordance with the provisions of section 144(2) of the said Act I hereby make the following regulations :—

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Grant-Aided Secondary Schools (Scotland) Grant (Amendment) Regulations 1969 and shall come into operation on 1st May 1969.

(2) These regulations shall be construed as one with the Grant-Aided Secondary Schools (Scotland) Grant Regulations 1959(b) (in these regulations referred to as “the principal regulations”) and with the Grant-Aided Secondary Schools (Scotland) Grant (Amendment) Regulations 1968(c) (in these regulations referred to as “the Amendment Regulations of 1968”).

Amendment of the principal regulations

2. The principal regulations shall be amended as follows :—

(1) in regulation 4 thereof there shall be substituted for paragraph (1) the following paragraph :—

“(1) Subject to the conditions prescribed in these regulations the Secretary of State may pay to the Managers of a recognised secondary school in aid of their approved expenditure on the maintenance of the school—

(a) in respect of the financial year of the school beginning after 1st April 1968 and ending before 1st January 1970 a grant of the amount specified in column (2) of the Schedule to these regulations opposite the name of the school in column (1) of that Schedule, and

(b) in respect of each financial year of the school beginning after 1st April 1969 a grant of the amount specified in column (3) of the

said Schedule opposite the name of the school in column (1) of that Schedule:

Provided that if the Secretary of State considers that the circumstances of any particular case justify him in so doing he may in lieu of the amount specified in column (2) or column (3) of the said Schedule pay such sum as he may determine being a sum not exceeding the sum whereby the said approved expenditure exceeds the income of the Managers from sources other than grants after deduction from the said income of any sums approved as being required for purposes other than the maintenance of the school.”;

(2) the Schedule to these regulations shall be substituted for the Schedule to the principal regulations as amended by the Amendment Regulations of 1968.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These regulations amend the provisions of the Grant-Aided Secondary Schools (Scotland) Grant Regulations 1959, empowering the Secretary of State to pay to the Managers of secondary schools not managed by education authorities grants in aid of their expenditure on the maintenance of the schools. The regulations provide that the amount of grant specified in the schedule to the 1968 amendment regulations against each school, or group of schools, may be paid to the school Managers only in respect of the financial year of that school, or group of schools, beginning after 1st April 1968 ; they specify a reduced amount of grant which may be paid to the said Managers in respect of the financial year of the school, or group of schools, beginning after 1st April 1969 and subsequent years.
