## EDUCATION, ENGLAND AND WALES

**The Remuneration of Teachers (Primary and Secondary Schools) Order 1969**

*Made* - - - - - *29th April 1969*

*Coming into Operation* *30th April 1969*

Whereas—

(1) in pursuance of section 2(2) of the Remuneration of Teachers Act 1965<sup>(a)</sup> (hereinafter referred to as “the Act”) the Committee constituted under section 1 of the Act for the purpose of considering the remuneration of teachers in primary and secondary schools maintained by local education authorities (hereinafter referred to as “the Committee”) have transmitted to the Secretary of State for Education and Science (hereinafter referred to as “the Secretary of State”) recommendations agreed on by them with respect to the remuneration of such teachers;

(2) in pursuance of section 2(3) of the Act, the Secretary of State has prepared a draft document setting out the scales and other provisions required for determining the remuneration of teachers of the description aforesaid in the form in which, in his opinion, those scales and provisions should be so as to give effect to those recommendations;

(3) the Secretary of State, as required by section 2(4) of the Act, has consulted the Committee with respect to the draft document and made such modifications thereof as were requisite for giving effect to representations made by the Committee; and

(4) the Secretary of State has arranged for a document setting out the requisite scales and other provisions in the form of the draft as modified as aforesaid to be published by Her Majesty’s Stationery Office on 28th April 1969 under the title “SCALES OF SALARIES FOR TEACHERS IN PRIMARY AND SECONDARY SCHOOLS, ENGLAND AND WALES, 1969”.

Now therefore the Secretary of State, in pursuance of section 2(4) of the Act, hereby orders as follows:—

*Citation and Commencement*

1. This Order may be cited as the Remuneration of Teachers (Primary and Secondary Schools) Order 1969 and shall come into operation on 30th April 1969.

*Interpretation*

2. The Interpretation Act 1889(a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

*Remuneration of Teachers*

3. The remuneration payable from 1st April 1969 to teachers in primary and secondary schools maintained by local education authorities shall be determined in accordance with the scales and other provisions set out in the document published by Her Majesty's Stationery Office as aforesaid.

*Revocation*

4. The Remuneration of Teachers (Primary and Secondary Schools) Order 1967(b), the Remuneration of Teachers (Primary and Secondary Schools) Amending Order 1968(c) and the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 2) Order 1968(d) are hereby revoked and section 38(2) of the Interpretation Act 1889 (which relates to the effect of repeals) shall have effect in relation to those Orders as if they were enactments repealed by an Act.

**EXPLANATORY NOTE**

*(This Note is not part of the Order.)*

This Order brings into operation the scales and other provisions relating to the remuneration of teachers in primary and secondary schools maintained by local education authorities set out in a document published by Her Majesty's Stationery Office. This document contains the recommendations of the Committee constituted under the Remuneration of Teachers Act 1965 for the purpose of considering the remuneration of such teachers.

The Order has effect from 1st April 1969 by virtue of section 7(3) of the Act.
