## HOUSING, ENGLAND AND WALES

The Isles of Scilly (Housing) Order 1969

The Minister of Housing and Local Government, in exercise of his powers under section 57 of the Housing (Financial Provisions) Act 1958(**a**), as applied by section 22 of and paragraph 7 of Schedule 3 to the Housing Subsidies Act 1967(**b**) (hereinafter called "the Act of 1967"), and of all other powers enabling him in that behalf, hereby makes the following order :---

1.—(1) This order may be cited as the Isles of Scilly (Housing) Order 1969 and shall come into operation on 19th May 1969.

(2) The Interpretation Act 1889(c) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

2.—(1) The provisions of Part I of the Act of 1967 which are specified in column (1) of the Schedule to this order shall extend to the Isles of Scilly.

(2) The said provisions as so extended shall have effect subject to the adaptations and modifications specified in respect thereof in column (2) of the said Schedule.

## EXPLANATORY NOTE

(This Note is not part of the Order.)

This order extends, subject to adaptations and modifications, certain provisions of Part I of the Housing Subsidies Act 1967 to the Isles of Scilly and thereby enables the Minister to give financial assistance to the Council of the Isles of Scilly towards the provision of new dwellings and to housing associations. The order also extends to the Isles certain consequential and supplemental provisions relating to housing subsidies.
