The Decimal Currency (Rating Instruments) Rules 1970

The Minister of Housing and Local Government, after consultation with the local authorities and the associations of local authorities with whom consultation appeared to him to be desirable, in exercise of his powers under section 113 of the General Rate Act 1967(a) and, as regards rule 7 hereof, section 13(5) of the Transport Act 1968(b), and of all other powers enabling him in that behalf, hereby makes the following rules:—

1. These rules may be cited as the Decimal Currency (Rating Instruments) Rules 1970 and shall come into operation on 1st November 1970.
2. The Interpretation Act 1889(c) applies to the interpretation of these rules as it applies to the interpretation of an Act of Parliament.
3. Rules 4 to 7 shall apply in relation to the year beginning with 1st April 1971 and subsequent years.
4. In the Precepts Rules 1965(d)—
for “s. d.”, wherever occurring, there shall be substituted “p”; and
for “1d.”, wherever occurring, there shall be substituted “1p”.
5. In the Rate-demands Rules 1965(e)—
for “£ s. d.”, wherever occurring, there shall be substituted “£”;
for “s. d.”, wherever occurring otherwise than in the expression “£ s. d.”, there shall be substituted “p”; and
for “1d.”, wherever occurring, there shall be substituted “1p”.
6. In the Rate Product Rules 1968(f)—
for “penny”, wherever occurring otherwise than in rule 6(2), there shall be substituted “new penny”; and
for “pence”, wherever occurring in paragraphs 2 and 6 of the Schedule, there shall be substituted “new pence”.
7. In the Rate Product (Passenger Transport Authorities) Rules 1970(g), in rule 3, for “penny”, wherever occurring, there shall be substituted “new penny”.
