The Fixed Penalty (Areas) (England and Wales) Order 1970

In pursuance of the powers conferred upon me by section 80 of the Road Traffic Regulation Act 1967^(a), I hereby make the following Order:—

1.—(1) This Order may be cited as the Fixed Penalty (Areas) (England and Wales) Order 1970 and shall come into operation on 1st September 1970.

(2) The Orders listed in the Schedule to this Order are hereby revoked.

2. Section 80 of the Road Traffic Regulation Act 1967 (which relates to the fixed penalty procedure) shall extend to the whole of England and Wales.

EXPLANATORY NOTE

(This Note is not part of the Order.)

Section 80 of the Road Traffic Regulation Act 1967 provides for the discharge of liability to conviction of certain traffic offences by the payment of a fixed penalty. The section extends only to such areas as the Secretary of State may by order specify. This Order extends the operation of the section to the whole of England and Wales and revokes previous Orders extending the section to particular areas.
