## LAND REGISTRATION

**The East Riding Deeds Registry (Decimalisation of Fees)  
Rules Confirmatory Instrument 1970**

*Made* - - - 27th November 1970

*Laid before Parliament* 10th December 1970

*Coming into Operation* 15th February 1971

Whereas the County Council of the East Riding of Yorkshire have, in exercise of their powers under sections 35 and 38 of the Yorkshire Registries Act 1884(a) as read with section 46(4) of the Local Government Act 1888(b), made rules in respect to fees and submitted them to the Lord Chancellor for his approval :

Now, therefore, the Lord Chancellor, in exercise of the powers conferred on him by section 35 of the said Act, hereby confirms the said rules in the form set out in the Schedule hereto.

This instrument may be cited as the East Riding Deeds Registry (Decimalisation of Fees) Rules Confirmatory Instrument 1970 and shall come into operation on 15th February 1971.

## SCHEDULE

The County Council of the East Riding of Yorkshire, in exercise of the powers conferred upon them by sections 35 and 38 of the Yorkshire Registries Act 1884 as read with section 46(4) of the Local Government Act 1888, hereby make the following Rules:—

1. These Rules may be cited as the East Riding Deeds Registry (Decimalisation of Fees) Rules 1970.

2. The fees payable under the Yorkshire Registries Act 1884 at the East Riding Deeds Registry shall be as follows:—

Registration or enrolment of any document (including endorsement of any certificate required by section 9 of the said Act) except a caveat .. .. .	37p
Registration or enrolment of any caveat .. .. .	10p
Copy or extract—	
where copy or extract does not exceed two folios ..	5p
for each additional folio .. .. .	2p
if certified, an additional fee per folio of .. .. .	1p
Map or plan—	
copy .. .. .	From 10p to £2.10 according to labour involved
if certified, an additional fee of .. .. .	10p
Search, ordinary—	
in any one name, for any period not exceeding ten years .. .. .	5p
for every additional period of five years .. .. .	3p
Search, official (including certificate of result)—	
in any one name, for any period not exceeding ten years .. .. .	37p
for every additional period of five years .. .. .	13p

3. The East Riding of Yorkshire Registry Rules 1890 (Fees) and the East Riding of Yorkshire Registry Rules 1941 (Fees Amendment) are hereby revoked.
