# The Price Stability of Imported Products (Rates of Levy) (Eggs) (No. 15) Order 1970

Made - - - 14th December 1970 Coming into Operation 15th December 1970

The Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by section 1(2), (4), (5), (6) and (7) of the Agriculture and Horticulture Act 1964(a) and of all other powers enabling him in that behalf, hereby makes the following order:—

- 1. This order may be cited as the Price Stability of Imported Products (Rates of Levy) (Eggs) (No. 15) Order 1970, and shall come into operation on 15th December 1970.
  - 2.—(1) In this order—
  - "the Principal Order" means the Price Stability of Imported Products (Levy Arrangements) (Eggs) Order 1970(b) as amended by any subsequent order, and if any such order is replaced by any subsequent order the expression shall be construed as a reference to such subsequent order;

AND other expressions have the same meaning as in the Principal Order.

- (2) The Interpretation Act 1889(c) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament and as if this order and the order hereby revoked were Acts of Parliament.
- 3. In accordance with and subject to the provisions of the Principal Order (which provides for the charging of levies on imports of those eggs and egg products which are specified commodities for the purposes of the Agriculture and Horticulture Act 1964) the rate of general levy for such imports into the United Kingdom of any specified commodity as are described in column 2 of the Schedule to this order in relation to a tariff heading indicated in column 1 of that Schedule shall be the rate set forth in relation thereto in column 3 of that Schedule.
- 4. The Price Stability of Imported Products (Rates of Levy) (Eggs) (No. 14) Order 1970(d) is hereby revoked.
  - In Witness whereof the Official Seal of the Minister of Agriculture, Fisheries and Food is hereunto affixed on 14th December 1970.

## **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This order, which comes into operation on 15th December 1970, supersedes the Price Stability of Imported Products (Rates of Levy) (Eggs) (No. 14) Order 1970. It—

- (a) reimposes rates of general levy on imports of eggs in shell in each of the weight grades which are numbered 1 to 6 in the Schedule to the order;
- (b) reimposes unchanged the rate of general levy to be charged on imports of whole dried eggs not in shell.
