The Prison (Scotland) (Amendment) Rules 1970

*Laid before Parliament in draft**Made - - - 18th December 1970**Coming into Operation 18th December 1970*

In exercise of the powers conferred on me by section 35 of the Prisons (Scotland) Act 1952(a) and of all other powers enabling me in that behalf, I hereby make the following rules a draft of which has lain before both Houses of Parliament in accordance with section 40(2) of the said Act.

1.—(1) These rules may be cited as the Prison (Scotland) (Amendment) Rules 1970.

(2) In these rules the expression “the principal rules” means the Prison (Scotland) Rules 1952(b) as amended by the Prison (Scotland) Rules 1956(c).

2. The principal rules shall be amended by the omission from the schedule thereto of the provisions for the constitution of the Visiting Committees for Barlinnie (Glasgow) and Greenock and the substitution of the following :—
