The Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 2) Order 1970

Made - - 18th February 1970

Coming into Operation 19th February 1970

Whereas-

- (1) in pursuance of section 2(2) of the Remuneration of Teachers Act 1965(a) (hereinafter referred to as "the Act") the Committee constituted under section 1 of the Act for the purpose of considering the remuneration payable to teachers in primary and secondary schools maintained by local education authorities (hereinafter referred to as "the Committee") have transmitted to the Secretary of State for Education and Science (hereinafter referred to as "the Secretary of State") certain recommendations agreed on by them with respect to the remuneration of such teachers:
- (2) there are in force orders made under section 2 of the Act with respect to the remuneration of such teachers, namely, the Remuneration of Teachers (Primary and Secondary Schools) Order 1969(b) and the Remuneration of Teachers (Primary and Secondary Schools) (Amendment) Order 1970(c);
- (3) it appears to the Secretary of State that effect can more conveniently be given to the recommendations of the Committee by amending the scales and other provisions set out in the document referred to in the said Orders, namely, the document published by Her Majesty's Stationery Office on 28th April 1969 under the title "SCALES OF SALARIES FOR TEACHERS IN PRIMARY AND SECONDARY SCHOOLS, ENGLAND AND WALES, 1969";
- (4) in pursuance of section 2(5) of the Act the Secretary of State has prepared a draft Order setting out the amendments of the scales and other provisions contained in the said document which, in his opinion, are requisite for giving effect to the recommendations of the Committee; and
- (5) the Secretary of State, as required by section 2(6) of the Act, has consulted the Committee with respect to the draft Order and the Committee have made no representations with respect thereto.

Now therefore the Secretary of State, in pursuance of section 2(6) of the Act, hereby orders as follows—

Citation and Commencement

1. This Order may be cited as the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 2) Order 1970 and shall come into operation on 19th February 1970.

Interpretation

2. The Interpretation Act 1889(a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Amendment of Document

- 3. The scales and other provisions set out in the Document are with effect
- from 1st April 1970 hereby amended in manner following, that is to say—
 (a) in paragraph 3(ii) of Section R thereof (which Section relates to additional payments for teachers in schools of exceptional difficulty) for "31st March 1970" there shall be substituted "31st March 1971"; and
 - (b) to paragraph 1 of Part A of Appendix VII thereof (which Appendix specifies qualifications entitling a qualified assistant teacher to receive an addition to the appropriate salary scale) there shall be added the following sub-paragraph:
 - "(vii) the successful completion of the One-Year Course of Training for Teachers of Visually Handicapped Children of the Department of Education of the University of Birmingham.'

EXPLANATORY NOTE

(This Note is not part of the Order.)

In accordance with recommendations agreed on by the Committee for the consideration of the remuneration of teachers in primary and secondary schools maintained by local education authorities, this Order extends by one year the period during which additional payments are to be made to teachers employed in schools recognised by the Secretary of State as of exceptional difficulty; it also adds a further qualification to those entitling teachers to an additional payment of £50 a year.
