**The University of Edinburgh (Fellowships, Scholarships
and Bursaries) Scheme 1971 Order in Council 1971**

At the Court at Buckingham Palace, the 12th day of November 1971

Present,

The Queen's Most Excellent Majesty in Council

Whereas the Scottish Universities Committee of the Privy Council (hereinafter referred to as "the Committee"), in exercise of the powers conferred on it by subsection (1) of section 126 of the Education (Scotland) Act 1962(a) as substituted by section 19 of the Education (Scotland) Act 1969(b), prepared a draft scheme entitled the University of Edinburgh (Fellowships, Scholarships and Bursaries) Scheme 1971 :

And whereas copies of the said draft scheme were sent to the governing body of the endowments to which it relates, and the draft scheme was duly published :

And whereas no objections or proposed amendments to the draft scheme were received by the Committee :

And whereas the Committee, in exercise of the powers conferred on it by subsection (2) of the said section 126, has made the scheme in the terms of the said draft scheme as published :

Now, therefore, Her Majesty, having taken the said scheme into consideration and in exercise of the powers conferred upon Her by subsection (2) of the said section 126, and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and does hereby order, as follows :—

1. The University of Edinburgh (Fellowships, Scholarships and Bursaries) Scheme 1971 as set out in the Schedule to this Order is hereby approved.

2. This Order may be cited as the University of Edinburgh (Fellowships, Scholarships and Bursaries) Scheme 1971 Order in Council 1971.

SCHEME UNDER THE EDUCATION (SCOTLAND) ACT 1962 AND THE EDUCATION (SCOTLAND) ACT 1969 FOR THE FUTURE GOVERNMENT AND MANAGEMENT OF THE ENDOWMENTS IN THE UNIVERSITY OF EDINBURGH NAMED AND DESCRIBED IN SCHEDULE 1 ANNEXED HERETO.

Whereas the endowments specified in schedule 1 to this scheme are University endowments within the meaning of section 135(1) of the Education (Scotland) Act 1962(a);

And Whereas the University Court of the University of Edinburgh have intimated in writing their consent to the said endowments being dealt with by the Scottish Universities Committee of the Privy Council in terms of section 118(5) of the Act of 1962;

And Whereas it appears to the said Committee that in order to extend the usefulness of the said endowments, arrangements should be made in accordance with the provisions of Part VI of the Act of 1962 as amended by the Education (Scotland) Act 1969(b) for the future government and management of the said endowments:

Therefore, from and after the date of this scheme, the said endowments shall be held and administered for the purposes, with the powers, and under the conditions hereinafter specified.

PART I

INTERPRETATION, CITATION AND COMMENCEMENT

Interpretation

1.—(1) In this scheme, unless the context otherwise requires—

“ Court ” means the University Court of the University of Edinburgh as defined in the Universities (Scotland) Acts 1858 to 1966(c) and acting as governing body of the endowments to which this scheme relates;

“ date of this scheme ” means the date upon which Her Majesty’s approval of this scheme is signified by Order in Council;

“ Faculty ” means a Faculty of the University constituted in terms of Ordinance No. 426 (Edinburgh No. 129), approved by Her Majesty in Council on 26th March 1964;

“ open bursary ” means a bursary in the patronage of the Senatus in the award of which no person is entitled to a preference under this scheme;

“ patron ” means a person or body other than the Senatus, holding the right to present candidates to bursaries under this scheme;

“ preferential bursary ” means a bursary in the award of which a specified class of persons is entitled to a preference under this scheme;

“ presentation bursary ” means a bursary in the patronage of persons or bodies other than the Senatus under this scheme;

“ Senatus ” means the Senatus Academicus of the University of Edinburgh constituted by the Universities (Scotland) Act 1858 as amended by the Universities (Scotland) Act 1966.

(2) The Interpretation Act 1889(d) shall apply to the interpretation of this scheme as it applies to the interpretation of an Act of Parliament.

(3) References in this scheme to any enactment, regulation or rule shall, except where the context otherwise requires, be construed as references to that enactment, regulation or rule as amended by or under any other enactment, regulation or rule, or as contained in any other enactment, regulation or rule substituted for that enactment, regulation or rule.

(4) References in this scheme to a Part, section or schedule shall, except where the context otherwise requires, be construed as references to a Part, section of or schedule to this scheme, as the case may be.

Citation and commencement

2.—(1) This scheme may be cited as the University of Edinburgh (Fellowships, Scholarships and Bursaries) Scheme 1971 and shall come into operation on the date of this scheme.

(2) All ordinances, schemes and deeds in operation immediately before the date of this scheme shall cease to have effect on the date of this scheme in so far as they relate to the endowments to which this scheme relates.

PART II

VESTING, CONSTITUTION AND CONTINUANCE OF FUNDS

Vesting of endowments

3. From and after the date of this scheme the endowments named and described in schedule 1 shall continue to be vested in the Court, and shall be held and administered by the Court exclusively in accordance with the conditions and provisions of this scheme.

Annual receipts

4.—(1) The Town Council of Edinburgh shall continue to pay each year to the Court from the funds of William Lennie's Trust the sum of £48.

(2) The said sum shall be added to the income of the Common Bursaries Fund constituted under section 5(1)(i).

Constitution and continuance of funds

5.—(1) From and after the date of this scheme the following funds shall be and are hereby constituted by the amalgamation of the endowments specified in the undernoted Parts of schedule 2:—

- (a) the Arts Faculty Scholarship Fund by the amalgamation of the endowments specified in Part I;
- (b) the Divinity Faculty Scholarship Fund by the continuance of the fund specified in Part II;
- (c) the Law Faculty Scholarship Fund by the amalgamation of the endowments specified in Part III;
- (d) the Medical Faculty Scholarship Fund by the amalgamation of the endowments specified in Part IV;
- (e) the Music Faculty Scholarship Fund by the amalgamation of the endowments specified in Part V;
- (f) the Science Faculty Scholarship Fund by the amalgamation of the endowments specified in Part VI;

- (g) the Social Sciences Faculty Scholarship Fund by the amalgamation of the endowments specified in Part VII;
- (h) the Veterinary Medicine Faculty Scholarship Fund by the amalgamation of the endowments specified in Part VIII;
- (i) the Common Bursaries Fund by the amalgamation of the endowments specified in Part IX; and
- (j) the Divinity Bursary Fund by the amalgamation of the endowments specified in Part X.

(2) The endowments specified in schedule 3 shall continue to be administered by the Court as separate funds.

(3) Each of the funds referred to in this section shall be held, administered and applied exclusively in accordance with the provisions of this scheme.

Additional Faculty Scholarship Funds

6. Following the creation of any additional Faculty or the sub-division or amalgamation of existing Faculties, it shall be in the power of the Court on the recommendation of the Senatus to establish additional Faculty Scholarship Funds or to sub-divide or amalgamate existing Faculty Scholarship Funds.

Scholarships may be re-allocated to a new Faculty which is closely related to the Faculty or to one of the Faculties in which the scholarship is tenable under this scheme.

Arts Faculty General Scholarship Fund

7. The Court shall divide any balance of the Arts Faculty General Scholarship Fund remaining at the date of this scheme into seven equal parts. Five of the said parts shall be added to and shall form part of the Arts Faculty Scholarship Fund constituted under section 5(1)(a), and two of the said parts shall be added to and shall form part of the Social Sciences Faculty Scholarship Fund constituted under section 5(1)(g).

Gunning (Victoria Jubilee) Divinity Fund

8.—(1) The Court shall divide the capital of the Gunning (Victoria Jubilee) Divinity Fund into four equal parts. One of the said parts shall constitute a fund which shall be known as the Gunning (Victoria Jubilee) Divinity Lecture Fund and three of the said parts shall constitute a fund which shall be known as the Gunning (Victoria Jubilee) Divinity Prize Fund.

(2) The Court shall apply the free annual income of the Gunning (Victoria Jubilee) Divinity Lecture Fund and the Gunning (Victoria Jubilee) Divinity Prize Fund in accordance with the provisions of sections 37 and 45 respectively.

Gunning (Victoria Jubilee) Medical Fund

9.—(1) The Court shall divide the capital of the Gunning (Victoria Jubilee) Medical Fund into three equal parts. One of the said parts shall be added to and shall form part of the Medical Faculty Scholarship Fund constituted under section 5(1)(d), and two of the said parts shall constitute a fund which shall be known as the Gunning (Victoria Jubilee) Medical Prize Fund.

(2) The Court shall apply the free annual income of the Gunning (Victoria Jubilee) Medical Prize Fund in accordance with the provisions of section 46.

Thomson Bursary Fund

10. The Court shall divide the capital of the Thomson Bursary Fund into six equal parts. Five of the said parts shall be added to and shall form part of the Common Bursaries Fund constituted under section 5(1)(i), and one of the said parts shall be added to and shall form part of the Divinity Bursary Fund constituted under section 5(1)(j).

Vans-Dunlop Arts Scholarship Fund

11. The Court shall divide the capital of the Vans-Dunlop Arts Scholarship Fund into seventeen equal parts. Twelve of the said parts shall be added to and shall form part of the Arts Faculty Scholarship Fund constituted under section 5(1)(a); two of the said parts shall be added to and shall form part of the Science Faculty Scholarship Fund constituted under section 5(1)(f); and three of the said parts shall be added to and shall form part of the Social Sciences Faculty Scholarship Fund constituted under section 5(1)(g).

Medical Faculty Scholarship Fund

12.—(1) The Court shall transfer from the capital of the Medical Faculty Scholarship Fund constituted under section 5(1)(d) the sum of £2,500 to form a fund which shall be known as the Vans-Dunlop Medical Prize Fund.

(2) The Court shall apply the free annual income of the Vans-Dunlop Medical Prize Fund in accordance with the provisions of section 48.

Peter Wilson Scholarship Fund

13.—(1) The Court shall divide the capital of the Peter Wilson Scholarship Fund into five equal parts. Four of the said parts shall be added to and shall form part of the Veterinary Medicine Faculty Scholarship Fund constituted under section 5(1)(h), and one part shall constitute a fund which shall be known as the Peter Wilson Lecture Fund.

(2) The Court shall apply the free annual income of the Peter Wilson Lecture Fund in accordance with the provisions of section 39.

PART III**FINANCIAL AND ADMINISTRATIVE ARRANGEMENTS***Powers of investment*

14. In regard to the investment of the funds constituted or continued by this scheme, or of additional endowments received in terms of section 15, the Court shall have all powers competent to them under the Common Law of Scotland as a body corporate.

Additional endowments

15. The Court may accept donations, legacies, annuities, subscriptions and other gifts, hereinafter referred to as "additional donations", for the purposes of this scheme or for purposes connected therewith and such additional donations shall be applied in accordance with the directions of the respective testators or donors. In the absence of any directions to the contrary the Court may apply any additional donations to the capital or income of any of the funds constituted or continued under this scheme, or to both capital and income of any such fund in such proportions as they think fit.

Application of income

16.—(1) The Court shall in each financial year pay from the income of the respective funds constituted or continued under this scheme the necessary expenses of management and the burdens and taxes affecting the funds, including such reasonable fees to examiners as they think fit.

(2) They shall thereafter in each financial year apply as nearly as possible the whole of the free income of the said funds in paying the fellowships, scholarships, bursaries, prizes and grants to which this scheme relates.

(3) If at the end of any financial year there is an unexpended balance of free income of any of the said funds, the Court, having regard to any recommendation made by the Senatus, shall determine whether the whole or a part of the said balance shall be added to the capital of the particular fund. Any part not so added shall be carried forward for application in the following year.

Method of payment of fellowships, etc.

17. It shall be in the power of the Court to pay the fellowships, scholarships, bursaries, prizes and grants to which this scheme relates in such instalments, at such periods, and subject to such conditions not being inconsistent with this scheme as the Court may prescribe.

Limitation of value of awards

18.—(1) The amount of any award under this scheme to a person who holds, or is to hold, a scholarship or other allowance which is paid out of monies provided by Parliament or out of any fund aided by grants from Parliament shall not be such as may cause the said scholarship or other allowance to be reduced.

(2) The holder of any award or awards governed by this scheme shall if required by the Senatus, furnish a statement of all other awards he holds. The Senatus shall have the right to adjust the value of any award made under this scheme to ensure that the combined annual value of all awards held by him shall not exceed such sum as the Senatus shall determine.

Rules

19. Subject to the provisions of this scheme, it shall be in the power of the Court and of the Senatus to make such rules as they think fit for the exercise of their respective functions under this scheme; provided that no rule shall be inconsistent with the provisions of this scheme.

Business arrangements

20. The business under this scheme of the Court and of the Senatus shall be conducted either at ordinary meetings or at meetings summoned for the purpose which shall be convened and conducted according to the ordinary rules and practice of the Court or of the Senatus, as the case may be.

Functions of the Senatus

21. It shall be in the power of the Senatus, with the approval of the Court, to make such regulations as they think fit for the exercise of their functions under this scheme. These functions shall include:—

- (a) the laying down, and variation, of the conditions of award and tenure of any fellowship, scholarship, bursary, prize, or grant from a fund to which this scheme relates;

- (b) the regulation of all examinations considered necessary for any award to which this scheme relates; and
- (c) the variation, on the recommendation of the Faculty or Faculties concerned of the value of any award, and of the number of awards to be made available in any one year.

Delegation of powers to Faculties

22. It shall be in the power of the Senatus to delegate to the Faculty or Faculties concerned or, in the case of bursaries to a Committee of the Senatus constituted for that purpose, the exercise of the powers and duties of the Senatus with regard to the award, tenure, or withholding of any fellowship, scholarship, bursary or prize to which this scheme relates.

Withdrawal of awards

23. The decision of the Senatus with regard to the functions detailed in section 21 shall be final. In cases, however, where the Senatus resolves to withdraw an award, whether permanently or temporarily, because they are satisfied that the holder is failing to make reasonable progress in the course of study or research which he has undertaken, for serious misconduct or for any other reason, the holder shall have the right to appeal to the Court within fourteen days from the date on which he received intimation of the said resolution of the Senatus. The decision of the Court shall then be final.

PART IV

FELLOWSHIPS AND SCHOLARSHIPS—GENERAL PROVISIONS

Faculty scholarship funds

24.—(1) The Senatus in exercise of the powers conferred on them by section 21, and on the recommendation of the Faculty concerned shall make awards from the Faculty Scholarship Funds constituted under section 5(1) (a) to (h) inclusive.

(2) In making available for award in any particular year any fellowship or scholarship (in this section referred to as “scholarship”) the Senatus shall, on the recommendation of the Faculty concerned:—

- (a) determine the particular subject with which it is to be connected; and
- (b) associate each such scholarship with an appropriate name from the names of the constituent endowments of the Faculty Scholarship Funds.

(3) The award of any scholarship from the Faculty Scholarship Funds may be made to persons who are attending, or have attended, or are about to attend, classes in the Faculty concerned, or who are about to undertake research work in the Faculty:

Provided that, save exceptionally, such a person shall be a matriculated student of the University or the holder of a first degree of a recognised University.

(4) Unless the Senatus shall decide otherwise, none of the scholarships awarded under this Part shall be tenable with any paid employment.

(5) It shall be in the power of the Senatus to permit any person to hold more than one scholarship at one time.

(6) Notwithstanding the provisions of this section the Senatus, on the recommendation of the Faculty of Music, may make awards from the Music Faculty Scholarship Fund in the form of entrance bursaries, after such examination as they deem expedient.

Additional payments

25. After the Senatus have exercised the powers conferred on them by section 24(1) the Court may, on the recommendation of the Senatus, and notwithstanding the provision of section 16(3), make additional payments:—

- (a) to a holder of a scholarship or fellowship, either towards defraying the expense of research work or as a grant in aid of the publication of research work undertaken by the holder of the said scholarship or fellowship.
- (b) from the Arts Faculty Scholarship Fund towards the cost of travel grants to students studying for honours degrees in the Faculty of Arts who are required to visit Italy or Greece, or both countries, in fulfilment of degree regulations.

Award of miscellaneous fellowships and scholarships

26. The Senatus, in exercise of the powers conferred on them by section 21 shall from time to time award the miscellaneous fellowships and scholarships specified in schedule 4 in accordance with the provisions of this scheme relative to the award of fellowships and scholarships but subject always to the conditions of award specified in column (2) opposite the fund named in column (1) of the said schedule.

PART V

BURSARIES—GENERAL PROVISIONS

Application of bursary funds

27.—(1) The Senatus in exercise of the powers conferred on them by section 21 shall award the bursaries specified in Parts I and II of schedule 5 forming the Common Bursaries Fund and the Divinity Bursary Fund constituted under section 5(1)(i) and (j).

(2) It shall be in the power of the Court to supplement the amount of any bursary awarded under the Common Bursaries Fund and the Divinity Bursary Fund from the income of the respective funds.

(3) Notwithstanding the provisions of section 16(3) it shall be in the power of the Court, on the recommendation of any Faculty and with the approval of the Senatus, to make grants to students in need of financial aid in that Faculty from the unused income of the relevant bursary fund.

General conditions of award and tenure of bursaries

28.—(1) The Senatus in exercise of the powers conferred on them by section 21, shall determine each year which of the bursaries specified in schedule 5, and within the patronage of the Senatus, shall be offered for award in the following year.

They shall publish in such manner as they think fit the names of the bursaries that are to be available for award in any year indicating the monetary value of each and furnishing where applicable details of the special conditions and Faculty preference shown in columns (4) and (5) opposite the bursary named in column (1) of schedule 5.

(2) It shall be in the power of the Senatus to conjoin any two or more bursaries and to fix the total annual value of such conjoined bursaries. The names of the bursaries affected shall be incorporated, so far as appropriate, in the name of the conjoined bursary, and in the award of such conjoined bursaries due regard shall be paid to any preference associated with one or more of the constituent bursaries.

(3) In the award of bursaries in any year the Senatus shall pay due regard to the preference attached to the bursaries offered for award in that year. Any candidate for a preferential bursary shall satisfy the Senatus that he is entitled to benefit by such preference. It shall be in the power of the Senatus to deem any preferential bursary an open bursary:

Provided that:—

- (a) no entry has been received for the bursary; or
- (b) candidates whose entries were accepted for the bursary have failed to attain the prescribed minimum standard required in the examination; or
- (c) candidates whose entries have been accepted and who have attained the prescribed minimum standard have been awarded other bursaries to which this scheme relates.

(4) The bursaries shall be tenable for such minimum number of years as is necessary to enable the holder to graduate. It shall be in the power of the Senatus to extend a holder's period of tenure of a bursary if he extends his course of study, with the approval of the Senatus, in order to graduate with Honours or to be a candidate for Honours after graduation. It shall also be in the power of the Senatus to extend a holder's period of tenure of a bursary if, with the approval of the Senatus, he extends or interrupts his course of study in order to complete an additional degree.

(5) The Senatus shall award bursaries on the basis of such entrance bursary examinations as they deem expedient to hold, or on the basis of such other examinations as they may determine, and it shall be in the power of the Senatus to offer awards only to candidates who have attained a minimum standard in any such prescribed examination, such minimum standard to be approved by the Senatus.

(6) Awards of bursaries from the Common Bursaries Fund shall be made only to students entering a Faculty of the University for the first time who have not previously been matriculated students of the University or of any other recognised University. Awards of bursaries from the Divinity Bursary Fund shall be made only to students entering the Faculty of Divinity for the first time.

Presentation bursaries

29.—(1) Upon each occasion of a vacancy in a presentation bursary the Senatus shall intimate the vacancy or impending vacancy to the patron entitled to present to the said bursary in terms of the conditions shown in column (6) of schedule 5 and column (4) of schedule 6 respectively of this scheme. The said patron shall be entitled at any time on or before the last day for receiving entries for the first convenient examination to present any person or persons qualified to compete for the said bursary.

(2) The Senatus shall offer the bursary for award subject to the terms of section 28 and the conditions of schedules 5 and 6 of this scheme.

Acquisition of presentation bursaries

30.—(1) It shall be in the power of the Court to open negotiations to acquire for the Senatus, a patron's right of presentation to a bursary.

(2) Where a patron wishes to sell his right of presentation to a bursary, he shall give notice of his intention to the Court, who shall within six months of the date of the notice inform the patron whether they wish to purchase the said right. The purchase price shall be fixed by agreement between the patron and the Court, or failing agreement, by an arbiter to be appointed by them.

(3) Where a right of presentation to a bursary is bought by the Court under this section it shall be in the power of the Court to defray the cost from the capital of the fund.

Bursar transferring from one Faculty to another

31. When the holder of a bursary named in schedules 5 or 6 who has begun a course in one Faculty transfers to another Faculty with the approval of the Dean of each of the said Faculties, the Senatus may allow him to continue to hold the bursary in the Faculty to which he has transferred.

Extension of bursaries to new Faculties

32. It shall be in the power of the Senatus following the creation of any additional Faculty or the sub-division or amalgamation of existing Faculties to decide with regard to the award of any bursary from the Common Bursaries Fund that a preference shall be accorded to students about to enter the new Faculty provided it is closely related to the Faculty or one of the Faculties in which the bursary is tenable under this scheme.

Power to vary basis of award of bursaries

33.—(1) Notwithstanding the provisions of this Part the Senatus, in exercise of their powers under section 21 may from time to time determine, with the approval of the Court, that part or all of the free annual income of the funds detailed in schedule 5 shall be applied to the award of bursaries on the basis of academic merit to matriculated students of not more than three years' standing. In approving regulations to give effect to such determination, the Court shall give twelve calendar months' notice, in such manner and to such bodies as they think fit, of the coming into effect of such regulations.

(2) The above subsection shall apply to any bursary in the patronage of persons or bodies other than the Senatus, if after due notice being given to any patron of the intention of the Senatus so to vary the conditions of award the said patron—

(a) shall signify his consent in writing, or

(b) shall fail to make formal objection within two months.

Miscellaneous bursaries

34. In awarding the bursaries specified in schedule 6, the Senatus shall have regard to the special conditions and Faculty preference shown in columns (2) and (3) opposite the bursary named in the said schedule.

PART VI

MISCELLANEOUS AND PRIZE FUNDS

Financial Aid Funds

35.—(1) The Senatus in exercise of the powers conferred on them by section 21 shall make grants from the funds specified in schedule 7 to any matriculated student of the University who is in need of financial aid to enable him to continue a recognised course of study in the University.

(2) In making grants the Senatus shall give preference to candidates who satisfy the Faculty preference and conditions of award shown in columns (2) and (3) opposite the fund named in column (1) of schedule 7.

In the absence of any such candidates the Senatus may make grants to candidates who either:—

- (a) satisfy the Faculty preference shown in column (2) opposite the fund named in column (1) of schedule 7; or
- (b) satisfy the conditions of award shown in column (3) opposite the fund named in column (1) of schedule 7.

Student Travel Funds

36. The Senatus in exercise of the powers conferred on them by section 21 shall make grants from the funds specified in schedule 8 to candidates who satisfy the conditions of award specified in column (2) opposite the fund named in column (1) of the said schedule.

Gunning (Victoria Jubilee) Divinity Lecture Fund

37. The Senatus, on the recommendation of the Faculty of Divinity, shall appoint lecturers and arrange for courses of lectures to be delivered in the Faculty of Divinity at intervals of not more than two years with the object of bringing out among candidates for the Ministry and among ministers the fruits of study in Science, Philosophy, Language, Antiquity and Sociology.

Munro Lectureship Fund

38.—(1) The Court, after consultation with the Senatus, shall appoint and fix the remuneration of a lecturer to the Munro Lectureship on Anthropology and Prehistoric Archaeology.

(2) The appointment shall be for such number of lectures as the Court shall determine, having regard to the particular branch of the subjects of the Lectureship to be treated by the lecturer, and the Court may renew the appointment for such further number of lectures as they consider desirable.

(3) The remainder of the free income of the fund shall be used by the Court to encourage archaeological and anthropological research, by means of grants for expenses, travelling grants or otherwise as they may decide.

Peter Wilson Lecture Fund

39. The Senatus, on the recommendation of the Faculty of Veterinary Medicine, shall from time to time arrange for lectures or courses of lectures for practitioners on advances made in Veterinary Science.

Dr. John Scott Travel Grants

40. It shall be in the power of the Court, on the nomination of the Professor of Clinical Surgery, to make grants to junior members of the staff of the Departments of Surgery to enable them to visit other surgical centres.

Bruce of Grangehill and Falkland Prize Fund

41. The Senatus shall award prizes to students of Logic in the Faculty of Arts for excellence in the study of Logic and Metaphysics. The said prizes shall be awarded on the recommendation of the Professor of Logic and Metaphysics.

Ellis Prize Fund

42. The Senatus shall at intervals of not more than three years offer for competition an Ellis Prize. The prize shall be awarded for the best essay or

treatise embodying original research in the field of Animal or Vegetable Physiology. The competition shall be open to Bachelors of Medicine and Bachelors of Surgery and to Bachelors of Science of the University, in each case of not more than five years' standing at the time of award, and to matriculated students of the University.

Forensic Prize Fund

43. The prize shall be offered for competition annually and shall be awarded to the student attending a class within the Department of Civil Law who submits the best essay on a subject connected with Civil Law prescribed by the Professor of Civil Law.

Gray's Prize Essay Fund

44. The Senatus shall each year offer one or more prizes for competitive essays in one or other of the following subjects as they think fit: Statistics, Politics, Government or Moral Philosophy. The competition shall be open to students attending the University who have matriculated for the first time not more than three years before the last date for submitting the competitive essays.

Gunning (Victoria Jubilee) Divinity Prize Fund

45. The Senatus shall each year offer for competition in the Faculty of Divinity such number of prizes, and in such subjects, as, on the recommendation of the Faculty of Divinity and after consultation with the Court, they may decide.

Gunning (Victoria Jubilee) Medical Prize Fund

46.—(1) The Senatus, on the recommendation of the Faculty of Medicine, shall each year offer for competition, four of the prizes listed in schedule 9, so that each prize is offered once in three years.

(2) The Senatus shall each year offer for competition two or more additional prizes in such subjects in the Faculty of Medicine as they think fit.

Jeffrey Bursary Fund (Prizes)

47.—(1) The Senatus shall each year offer for competition at the close of the winter session Jeffrey Prizes in Divinity; Church History; Hebrew; and Biblical Criticism. Each of the said prizes shall be awarded to the student studying for the ministry of the Church of Scotland who has taken the highest place in the competitive examination in the subject to which the prize is attached, on condition that during the ensuing summer session he shall continue the study of the subject to which the prize is attached in the Faculty of Divinity of another University or in a Theological Institution as the Senatus shall approve.

(2) Notwithstanding the provisions of section 16(3) of the scheme, if at the end of any financial year there is an unexpended balance of free income in the Jeffrey Bursary Fund, the said balance shall be paid into the Divinity Bursary Fund.

Vans-Dunlop Medical Prize Fund

48. The Senatus shall each year offer for competition in the Faculty of Medicine two prizes to be named Vans-Dunlop Prizes. One of the said prizes shall be in Chemistry and Physics and the other in Biology. They shall be awarded after such examination as the Senatus may prescribe to matriculated students in the Faculty of Medicine of the University.

PART VII

MISCELLANEOUS AND GENERAL PROVISIONS

Continuation of benefits

49. Any person who at the date of this scheme is a beneficiary under any of the endowments to which this scheme relates shall continue to enjoy the benefits thereof subject always to the conditions under which it was awarded.

Copies of scheme

50. The Court shall maintain a supply of printed copies of this scheme and shall cause a copy to be kept available for inspection by any member and officer of the Court, and copies shall be made available to the public at a reasonable price.
