EDUCATION, ENGLAND AND WALES

The Direct Grant Schools (Amendment) Regulations 1972

Made - - - 7th November 1972

Laid before Parliament 15th November 1972

Coming into Operation 8th December 1972

The Secretary of State for Education and Science and the Secretary of State for Wales, in joint exercise of the powers conferred by section 100(1)(b) of the Education Act 1944(a) and vested in them (b), hereby make the following regulations:—

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Direct Grant Schools (Amendment) Regulations 1972 and shall come into operation on 8th December 1972.

(2) The Interpretation Act 1889(c) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Increase in capitation grant

2.—(1) In respect of the educational year ending on 31st July 1972, in addition to the capitation grant payable to the proprietors of the grammar school under regulation 4(1)(a) (“the principal provision”) of the Direct Grant Schools Regulations 1959(d) as amended (e) and the supplementary capitation grant payable to them under regulation 2(1) of the Direct Grant Schools (Amendment) Regulations 1971, there may be paid under the principal provision an additional supplementary capitation grant at a rate not exceeding £3.

(2) In respect of any educational year beginning after 31st July 1972 capitation grant shall be payable under the principal provision at a rate not exceeding £71 and accordingly for the reference in that provision to £62 there shall be substituted a reference to £71.
