THERAPEUTIC SUBSTANCES

The Therapeutic Substances (Supply of Antibiotics and Chemotherapeutic Substances for Agricultural Purposes) Amendment (No. 2) Regulations 1972

Made - - - 7th November 1972

Laid before Parliament 16th November 1972

Coming into Operation 11th December 1972

The Secretary of State for Social Services, the Secretary of State for Wales, the Secretary of State for Scotland and the Secretary of State for Northern Ireland, acting jointly, in exercise of their powers under section 9 of the Therapeutic Substances Act 1956(a), as amended by Article 2(2) of, and Schedule 1 to, the Transfer of Functions (Wales) Order 1969(b) and as having effect subject to the provisions of section 1(1)(a) of the Northern Ireland (Temporary Provisions) Act 1972(c) and of all other powers enabling them in that behalf, after consultation with the Medical Research Council and the Agricultural Research Council, hereby make the following regulations:—

Citation and commencement

1. These regulations may be cited as the Therapeutic Substances (Supply of Antibiotics and Chemotherapeutic Substances for Agricultural Purposes) Amendment (No. 2) Regulations 1972 and shall come into operation on 11th December 1972.

Interpretation

2. The Interpretation Act 1889(d) shall apply to the interpretation of these regulations as it applies to the interpretation of an Act of Parliament.

Amendment of the Therapeutic Substances (Supply of Antibiotics and Chemotherapeutic Substances for Agricultural Purposes) Regulations 1971

3. The Therapeutic Substances (Supply of Antibiotics and Chemotherapeutic Substances for Agricultural Purposes) Regulations 1971(e) (as amended) (f) shall be further amended as follows:—

- (a) in regulation 2(1) (Interpretation) after the words ‘“feeding stuffs containing sulphaquinoxaline” means’ there shall be inserted the words “rabbit or”; and
- (b) in Schedule 1 in column (2) below the number 156 (indicating the maximum number of parts of sulphaquinoxaline to one million parts of feeding stuff) there shall be inserted the number 94, and in column

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Therapeutic Substances (Supply of Antibiotics and Chemotherapeutic Substances for Agricultural Purposes) Regulation 1971 (as amended) by extending permitted sale or supply without prescription to animal feeding stuffs containing sulphaquinoxaline for the feeding of rabbits, subject to the conditions contained in those Regulations.
