EDUCATION, SCOTLAND

The Teachers (Colleges of Education) (Scotland) Amendment Regulations 1972

Made - - - 1st December 1972 Laid before Parliament 13th December 1972 Coming into Operation 5th January 1973

In exercise of the powers conferred on me by section 81(1) of the Education (Scotland) Act 1962(a), as substituted by section 15 of the Education (Scotland) Act 1969(b), and by section 144(5) of the said Act of 1962, and of all other powers enabling me in that behalf, I hereby make the following regulations:—

Citation, construction and commencement

1. These regulations, which may be cited as The Teachers (Colleges of Education) (Scotland) Amendment Regulations 1972, shall be read as one with the Teachers (Colleges of Education) (Scotland) Regulations 1967(c) as amended(d), (hereinafter referred to as "the principal regulations") and shall come into operation on 5th January 1973.

Amendment of the principal regulations

- 2. In regulation 13 of the principal regulations—
 - (a) in paragraph (1)—
 - (i) in sub-sub-paragraphs (i) and (ii) of sub-paragraph (b) the words ", which qualification shall be awarded only to women" shall be omitted;
 - (ii) for sub-sub-paragraph (iv) of sub-paragraph (b) there shall be sub-stituted the following sub-sub-paragraphs—
 - "(iv) a remedial teacher in a primary school or department; or (ivA) a remedial teacher in a secondary school or department; or";
 - (iii) in sub-paragraph (d) for the words "youth or community service" there shall be substituted the words "youth and community service";
 - (iv) after sub-paragraph (d) there shall be inserted the following sub-paragraphs—
 - "(dd) courses leading to a qualification for social work;
 - (ddd) courses for the further training of social workers;";
 - (b) in paragraph (2) for the words "sub-paragraphs (c) and (d)" there shall be substituted the words "sub-paragraphs (c), (d) and (ddd)";
 - (c) after paragraph (3), there shall be inserted the following paragraph—
 "(4) A governing body may, after consultation with such other gov-

erning bodies as appear to it to be concerned, award a special qualification of any of the kinds specified in sub-sub-paragraphs (i) to (v) of sub-paragraph (b) of paragraph (1) above to any registered teacher who, as a result of specialist training undertaken outside Scotland or of practical experience as a teacher or of other special circumstances, has, in its opinion, reached a standard comparable to that attained by any teacher who has successfully completed a course of the kind specified in said sub-paragraph (b) as leading to that qualification.".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Teachers (Colleges of Education) (Scotland) Regulations 1967, as amended, to extend the award of nursery school and infant teacher special qualifications to men; to provide, in place of the special qualification in relation to backward pupils, for courses leading to a special qualification as a remedial teacher in primary schools or in secondary schools; to provide for courses of training for social work; and to enable the governing body of a college of education to award a special qualification to a registered teacher who, although he has not undertaken special training in Scotland, is, in their opinion, qualified for such an award.
