The Diving Operations (Diver's Fitness Register) Order 1972

Made 12th December 1972 Coming into Operation 1st February 1973

The Secretary of State in exercise of powers conferred by Regulation 9 of the Diving Operations Special Regulations 1960(a) and now vested in him(b) and of all other powers enabling him in that behalf, hereby makes the following Order:-

- 1.—(1) This Order may be cited as the Diving Operations (Diver's Fitness Register) Order 1972 and shall come into operation on 1st February 1973.
- (2) The Order prescribing the form of diver's fitness register for the purposes of Regulation 9 of the said Regulations made by the Minister of Labour on 28th June 1960 is hereby revoked.
- 2. The Interpretation Act 1889(c) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament, and as if this Order and the Order hereby revoked were Acts of Parliament.
- 3. The diver's fitness register required by Regulation 9 of the Diving Operations Special Regulations 1960 to be issued in respect of a person before he is employed under water as a diver shall be in the form set out in the Schedule to this Order.
