#### **PROCEDURE**

## The County Court (Amendment) Rules 1972

Made 16th February 1972 1st March 1972 Coming into Operation

- 1.—(1) These Rules may be cited as the County Court (Amendment) Rules 1972.
- (2) In these Rules an Order and Rule referred to by number means the Order and Rule so numbered in the County Court Rules 1936(a), as amended (b), and a form referred to by number means the form so numbered in Appendix A to those Rules.
- (3) The Interpretation Act 1889(c) shall apply for the interpretation of these Rules as it applies for the interpretation of an Act of Parliament.
  - 2. In Order 10, Rule 4(4), the words "of the action" shall be omitted.
  - 3. Order 46, Rule 13, shall be amended as follows:—
  - (1) For paragraph (3) there shall be substituted the following paragraph: "(3) Every action against the Crown (other than an Admiralty action) shall, notwithstanding anything in Order 6, Rule 2, or Order 26, Rule 8, be an ordinary action."
  - (2) In paragraph (4)(g) after the word "hearing" there shall be inserted the words "as if Order 6, Rule 3(3), did not apply".
  - (3) In paragraph (8)(a) for the figure "18" in sub-paragraph (i) there shall be substituted the figure "18(1)" and for sub-paragraph (ii) there shall be substituted the following sub-paragraph:
    - "(ii) in Form 18A the section headed "Counterclaim" shall be deleted, and".
  - (4) In paragraph (12) after the word "accordingly" there shall be inserted the words "Order 21, Rule 4, Order 24, Rule 10(1), and".

- 4. In Form 11 the words "and does not exceed £100", in both places where they appear, shall be omitted.
- 5. In Forms 28(1), 60 and 61 for the words "the whole of your claim" to "made by defendant:" there shall in each case be substituted the words "your claim and a copy is attached".
