**The Price Stability of Imported Products (Levy Arrangements)
 (Eggs) (Amendment) Order 1972**

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with agriculture in Scotland and Northern Ireland, acting jointly in exercise of the powers conferred on them by section 1(2), (4), (6) and (7) of the Agriculture and Horticulture Act 1964(a) and of all other powers enabling them in that behalf, with the approval of the Treasury, hereby make the following order:—

1.—(1) This order may be cited as the Price Stability of Imported Products (Levy Arrangements) (Eggs) (Amendment) Order 1972, and shall come into operation on 1st May 1972.

(2) The Interpretation Act 1889(b) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

2. The Price Stability of Imported Products (Levy Arrangements) (Eggs) Order 1970(c) as amended(d) shall be further amended by inserting in paragraph 2 of Part I of the Schedule thereto immediately after the words “the Republic of South Africa” the word “or” and by deleting from that paragraph the words “or the Kingdom of the Netherlands”.

(This Note is not part of the Order.)

This order further amends the Price Stability of Imported Products (Levy Arrangements) (Eggs) Order 1970 to remove the exemption from general levy of imports of liquid, frozen or dried whole egg which has been processed from shell eggs in the Netherlands and consigned to the United Kingdom from that country.
