**The Plant Varieties (Performance Trials) (Amendment)
Regulations 1972**

The Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland and the Secretary of State for Northern Ireland, acting jointly, in exercise of the powers vested in them by section 22(10) of the Plant Varieties and Seeds Act 1964(a) (extended to Northern Ireland by the Plant Varieties and Seeds (Northern Ireland) Order 1964(b)), and of all other powers enabling them in that behalf, with the approval of the Treasury, hereby make the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Plant Varieties (Performance Trials) (Amendment) Regulations 1972 and shall come into operation on 22nd May 1972.

Amendment of principal Regulations

2. The Plant Varieties (Performance Trials) Regulations 1969(c) as amended by the Plant Varieties (Performance Trials) (Amendment) Regulations 1970(d) are hereby further amended by substituting for schedule 5 thereto (as substituted by the Plant Varieties (Performance Trials) (Amendment) Regulations 1970) the following schedule:—
