**The Price Stability of Imported Products (Rates of Levy)  
(Cereals) (No. 15) Order 1972**

*Made - - - - 28th April 1972*

*Coming into Operation 1st May 1972*

The Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by section 1(2), (4), (5), (6) and (7) of the Agriculture and Horticulture Act 1964(a) and of all other powers enabling him in that behalf, hereby makes the following order:—

1. This order may be cited as the Price Stability of Imported Products (Rates of Levy) (Cereals) (No. 15) Order 1972, and shall come into operation on 1st May 1972.

2.—(1) In this order—

“the Principal Order” means the Price Stability of Imported Products (Levy Arrangements) (Cereals) Order 1971(b), as amended by any subsequent order and if any such order is replaced by any subsequent order the expression shall be construed as a reference to such subsequent order;

AND other expressions have the same meaning as in the Principal Order.

(2) The Interpretation Act 1889(c) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament and as if this order and the orders hereby revoked were Acts of Parliament.

3. In accordance with and subject to the provisions of Part II of the Principal Order (which provides for the charging of levies on imports of certain specified commodities) the rate of levy for such imports into the United Kingdom of any specified commodity as are described in column 2 of the Schedule to this order in relation to a tariff heading indicated in column 1 of that Schedule shall be the rate set forth in relation thereto in column 3 of that Schedule.

4. The Price Stability of Imported Products (Rates of Levy) (Cereals) (No. 14) Order 1972(d) is hereby revoked.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This order, which comes into operation on 1st May 1972, supersedes the Price Stability of Imported Products (Rates of Levy) (Cereals) (No. 14) Order 1972.

It—

- (a) removes the rates of levy to be charged on imports of—
  - (i) wheat flours not containing chalk and containing not more than 1 per cent. by weight of fibre at the prescribed standard moisture content under tariff heading 11.01;
  - (ii) processed oats within tariff heading 11.02,
- (b) reduces to £4.00 per ton the rate of levy to be charged on imports of processed barley within tariff heading 11.02,
- (c) increases the rate of levy to be charged on imports of—
  - (i) wheat (other than denatured wheat) to £8.50 per ton;
  - (ii) barley other than barley having a potential diastatic activity of not less than 170 degrees to £5.75 per ton;
  - (iii) oats, maize (other than sweet corn on the cob), grain sorghum and processed maize within tariff heading 11.02 to £6.50, £5.25, £3.75 and £5.50 per ton respectively, and
- (d) reimposes unchanged the rate of levy to be charged on imports of denatured wheat.
