**The Foreign Sea-Fishery Officers (International Commission for the Northwest Atlantic Fisheries Scheme) Variation Order 1972**

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea-fishing industry in Scotland and Northern Ireland in exercise of the powers conferred on them by sections 7(4) and 18(3) of the Sea Fisheries Act 1968(a) and of all other powers enabling them in that behalf, hereby make the following Order:—

*Citation, Commencement and Interpretation*

1.—(1) This Order may be cited as the Foreign Sea-Fishery Officers (International Commission for the Northwest Atlantic Fisheries Scheme) Variation Order 1972 and shall come into operation on 6th July 1972.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

*Variation of Principal Order*

2. The Foreign Sea-Fishery Officers (International Commission for the Northwest Atlantic Fisheries Scheme) Order 1971(c) is hereby varied by the insertion in Schedule 2 thereto of the following:—

“13. Federal Republic of Germany”

This Order varies the Foreign Sea-Fishery Officers (International Commission for the Northwest Atlantic Fisheries Scheme) Order 1971. It adds the Federal Republic of Germany to the countries listed in Schedule 2 to the principal Order thereby including in the class of persons specified in the principal Order officers nominated by that country who are to be foreign sea-fishery officers for the purposes of the Scheme of Joint Enforcement of the Northwest Atlantic Fisheries Commission.
