The Lincolnshire River Authority (Alteration of Boundaries of the Skegness District Internal Drainage District) Order 1973

Made - - - -

4th July 1973

Coming into Operation

20th August 1973

Whereas the Lincolnshire River Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 4(1)(b) of the Land Drainage Act 1930(a) in relation to the Skegness District Internal Drainage District:

And whereas the Minister has decided to confirm the Scheme, a copy of which is annexed hereto:

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 4(3) and 14 of the Land Drainage Act 1930, as applied by the Water Resources Act 1963(b), and of every other power enabling him in that behalf, hereby orders as follows:—

1. This Order, which may be cited as the Lincolnshire River Authority (Alteration of Boundaries of the Skegness District Internal Drainage District) Order 1973, shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. The Scheme is hereby confirmed.

4. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Lincolnshire River Authority and shall be part of the administrative expenses of that Authority.

LAND DRAINAGE ACT 1930
LINCOLNSHIRE RIVER AUTHORITY
SKEGNESS DISTRICT INTERNAL DRAINAGE DISTRICT

The Lincolnshire River Authority (hereinafter called "the River Authority") in pursuance of sub-section (1)(b) of section 4 of the Land Drainage Act 1930, as applied by the Water Resources Act 1963, submit to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation under sub-section (3) of the said section 4 of the said Act of 1930, the following Scheme for:—

1. the alteration of the boundaries of the Skegness District Internal Drainage District (hereinafter called "the Internal Drainage District");
2. matters supplemental thereto or consequential thereon.

SCHEME

1. This Scheme (which includes the Schedule hereto) may be cited as the Lincolnshire River Authority (Skegness District Internal Drainage District) Scheme 1972 and shall come into operation on a day to be appointed by the Minister and such day is hereinafter called "the appointed day".

2. The boundaries of the Internal Drainage District as constituted under the Schemes and confirming Orders referred to in the said Schedule immediately before the appointed day shall be altered so as to include in the Internal Drainage District all those lands (hereinafter called "the said lands") lying in the Parish of Wainfleet St. Mary in the County of Lincoln Parts of Lindsey which are shown coloured pink and edged with a red line on the map sealed by the River Authority in relation to this Scheme.

3. The provisions of the Schemes and confirming Orders referred to in the said Schedule shall, where applicable, apply to the said lands as if such lands had formed part of the Internal Drainage District immediately before the appointed day.

SCHEDULE

The Scheme confirmed (with an amendment) by the Witham and Steeping Rivers Catchment Board (Skegness District Internal Drainage District) Order 1934(a).

The Scheme confirmed (with modifications) by the Lincolnshire River Board (Alteration of Boundaries of the Skegness District Internal Drainage District) Order 1956(b).

The Scheme confirmed by the Lincolnshire River Board (Alteration of Boundaries of the Skegness District Internal Drainage District) Order 1957(c).

The Scheme confirmed by the Lincolnshire River Authority (Alteration of Boundaries of the Skegness District Internal Drainage District) Order 1967(d).

EXPLANATORY NOTE

(This Note is not part of the Order.)
