## The Electricity Areas (Peterborough New Town) Order 1973

Made - - - 5th December 1973

Laid before Parliament 13th December 1973

Coming into Operation 7th January 1974

The Secretary of State, after consultation with the Electricity Council and after giving to the Eastern Electricity Board and the East Midlands Electricity Board an opportunity to make representations, in exercise of powers conferred by section 4(2) of the Electricity Act 1947(a) and now vested in him(b) and of all other powers in that behalf enabling him, hereby makes the following Order:—

- 1.—(1) This Order shall come into operation on 7th January 1974 and may be cited as the Electricity Areas (Peterborough New Town) Order 1973.
- (2) The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2.—(1) The areas for which the Eastern Electricity Board and the East Midlands Electricity Board were established (such areas being in this Order respectively referred to as "the Eastern Area" and "the East Midlands Area") are hereby varied to the extent that there shall be included in the Eastern Area and excluded from the East Midlands Area the parish of Ailsworth and those parts of the parishes of Upton and Sutton to the south and east of an irregular line drawn from the River Nene near Sutton Toll to the eastern boundary of the parish of Upton near Blind Lane, Upton, which (together with the said parish of Ailsworth) are shown coloured pink on the map referred to in paragraph (2) of this Article and are situated in the County of Northampton.
- (2) The new boundary constituted by this Order between the Eastern Area and the East Midlands Area shall be the boundary shown on a map certified under the hand of the Minister for Industry, Department of Trade and Industry, at the making of this Order to be the map relating to the variation effected by this Order.
