The Import Duties (General) (No. 9) Order 1973

Articles 1 and 2 1st January 1974 Article 3 1st February 1974

The Lords Commissioners of Her Majesty's Treasury, by virtue of the powers conferred on them by sections 1, 2, 3(6) and 13 of the Import Duties Act 1958(a) as amended by section 5(5) of, and paragraph 1 of Schedule 4 to, the European Communities Act 1972(b) and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State (c) hereby make the following Order:

- 1.—(1) This Order may be cited as the Import Duties (General) (No. 9) Order 1973.
- (2) Articles 1 and 2 of this Order shall come into operation on 1st January 1974 and Article 3 shall come into operation on 1st February 1974.
- (3) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (4) This Order does not increase duties of customs otherwise than in pursuance of a Community obligation.
- 2.—(1) Schedules 1, 2 and 3 to the Import Duties (General) (No. 8) Order 1973(e) (hereinafter referred to as the "principal Order") shall be amended as specified in Parts I, II and III respectively of Schedule 1 to this Order.
- (2) In consequence of the addition, by virtue of paragraph (1) above, of a fourth Part to Schedule 2 to the principal Order, Article 3(2) of the principal Order shall be amended by the addition, after the words "being goods temporarily exempt", of the words ", or goods relieved,".
- 3. Schedule 1 to the Import Duties (General) No. 8) Order 1973 shall be further amended as specified in Schedule 2 hereto (such amendments taking effect on 1st February 1974).

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order, which comes into operation generally on 1st January 1974, provides for amendments and additions to the Import Duties (General) (No. 8) Order 1973 which sets out the United Kingdom Customs Tariff and the protective import duties chargeable in accordance with it.

The amendments are made—

- (a) to take account of changes being made on 1st January 1974 and 1st February 1974 in the Common Customs Tariff of the European Economic Community (Part I of Schedule 1 and Schedule 2 respectively);
- (b) to correct certain typographical errors in that Order (Schedule 1);
- (c) to delete five subdivisions of tariff heading 37.07 which are not required because film of the description in subheading 37.07 A.II.b) can only be classified as intermediate positives and therefore cannot fall within subheading 37.07 B. (Part I of Schedule 1).

In addition the Order provides for the continuation of duty-free entry previously granted under the Import Duty Reliefs (No. 5) Order 1958 for certain silk-screen and similar prints and certain artists materials described in Part II of Schedule 1 to this Order.
