LOCAL GOVERNMENT, ENGLAND AND WALES

The Royal Borough of Kensington and Chelsea (Wards)

Order 1973

Made - - - - 31st December 1973

Coming into Operation 16th February 1974

Whereas in pursuance of section 51(1) of the Local Government Act 1972(a), the Local Government Boundary Commission for England on 23rd October 1973 submitted to me proposals for a substantive change in the electoral arrangements for the Royal borough of Kensington and Chelsea:

Now, therefore, I, the Right Honourable Robert Carr, one of Her Majesty's Principal Secretaries of State, in exercise of the power conferred upon me by sections 51(2) and 67 of the said Act, do hereby make the following Order:—

1. This Order may be cited as the Royal Borough of Kensington and Chelsea (Wards) Order 1973.

2. This Order shall come into operation on 16th February 1974:

Provided that for the purpose of all proceedings preliminary or relating to an election to be held on or after that day the said Order shall come into operation forthwith.

3. The map referred to in this Order is the map marked "MAP REFERRED TO IN THE ROYAL BOROUGH OF KENSINGTON AND CHELSEA (WARDS) ORDER 1973" and deposited with the Secretary of State.

4. The existing wards of the Royal borough of Kensington and Chelsea shall be abolished, and the said borough shall be divided into twenty-one wards which shall bear the names set out in column 1 of the Schedule to this Order, and each such ward shall comprise the area designated on the map by reference to the name of the ward and demarcated by red lines thereon.

5. Where a boundary is shown on the map as running along a road, footpath, railway, track or river, it shall be treated as running along the centre line thereof.

6. The number of councillors to be elected for each ward constituted by this Order shall be the number specified in column 2 of the said Schedule opposite to the name of the ward as given in column 1 of that Schedule.

7.—(1) The wards constituted by this Order shall have the internal boundaries thereof mered by Ordnance Survey.

(2) Copies of the map, marked "COPY OF THE MAP REFERRED TO IN THE ROYAL BOROUGH OF KENSINGTON AND CHELSEA (WARDS) ORDER 1973", shall be deposited with the council of the Royal borough of Kensington and Chelsea and with the Director General of the Ordnance Survey and such copies shall at all reasonable times be open to inspection by any person

8. The Town Clerk of Kensington and Chelsea shall make such re-arrangement or alteration of the register of electors published in the year 1974 as may be necessary on account of the coming into operation of this Order.
