**The National Health Service (Designation of London  
 Teaching Hospitals) Amendment Order 1973**

*Made* - - - 13th March 1973

*Coming into Operation* 26th March 1973

The Secretary of State for Social Services, in exercise of his powers under section 11(9) of the National Health Service Act 1946(a) and of all other powers enabling him in that behalf, and after consultation with the University of London, hereby orders as follows:—

1. This order may be cited as the National Health Service (Designation of London Teaching Hospitals) Amendment Order 1973 and shall come into operation on 26th March 1973.

2. The Interpretation Act 1889(b) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

3. Schedule 1 to the National Health Service (Designation of London Teaching Hospitals) Order 1957(c) as amended(d) (which Schedule prescribes designated London teaching hospitals), shall be further amended as follows:—

- (1) In column (2) of the said Schedule opposite the name “The Royal Hospital of St. Bartholomew” in column (1) the words “(including the Zachary Merton Convalescent Home, Northwood, Middlesex.)” shall be deleted.
- (2) In column (2) of the said Schedule opposite the name “The London Hospital” in column (1) after the words “The London Hospital” the word “(Whitechapel)” shall be inserted. For the words “Mile End Hospital” there shall be substituted the words “The London Hospital (Mile End)” and for the words “St. Clement’s Hospital” there shall be substituted the words “The London Hospital (St. Clement’s)”.

- (3) In column (2) of the said Schedule opposite the words "The Royal Free Hospital" in column (1) for the words "The London Fever Hospital, N1" there shall be substituted the words "The Royal Free Hospital, Liverpool Road Branch, Islington, N1". For the words "The North Western Hospital, Hampstead, NW3" there shall be substituted the words "The Royal Free Hospital, Lawn Road Branch, Hampstead, NW3".
- (4) In column (2) of the said Schedule opposite the name "University College Hospital" in column (1) the words "The North London or" shall be deleted. The word "and" following the words "Obstetric Hospital" shall be deleted. After the words "The Royal Ear Hospital, Huntley Street, WC1" there shall be added the words "the Dental Hospital, Mortimer Market, WC1, and University College Hospital Annexe, 23 Devonshire Street, W1."
- (5) In column (2) of the said Schedule opposite the name "The Middlesex Hospital" in column (1) after the word "including" there shall be added the words "The Recovery and Geriatric Unit," and after the word "Hampstead" there shall be added the word "Lane". There shall be deleted the words "The Arthur Stanley Institute for Rheumatic Diseases, Peto Place, NW1."
- (6) In column (2) of the said Schedule opposite the name "St. George's Hospital" in column (1) for the words "Atkinson Morley Convalescent Hospital" there shall be substituted the words "Atkinson Morley's Hospital". After the words "St. George's Hospital, Tooting SW17" there shall be added the words "The Wolfson Medical Rehabilitation Centre, SW20."
- (7) In column (2) of the said Schedule opposite the name "Westminster Hospital" in column (1) there shall be deleted the words "Westminster Hospital Chest Clinic, SW1".
- (8) In column (2) of the said Schedule opposite the name "St. Mary's Hospital" in column (1) after the words "Joyce Grove Convalescent Home, Nettlebed, Oxon." there shall be added the words "and Chepstow Lodge Pre-Convalescent Annexe, W2". After the words "The Princess Louise (Kensington) Hospital" there shall be deleted the words "for Children".
- (9) In column (2) of the said Schedule opposite the name "Guy's Hospital" in column (1) for the words "Guy's Hospital Annexe" there shall be substituted the words "Bermondsey Out-Patient Clinic". After the words "Dunoran Home" there shall be inserted the word "Park".
- (10) In column (2) of the said Schedule opposite the name "King's College Hospital" in column (1) after the words "The Belgrave Hospital for Children, SW9" there shall be deleted the words "(including the Belgrave Hospital Recovery Home, Walton-on-Thames, Surrey)". There shall be deleted the words "Lambeth Chest Clinic, London SE22, The Rheumatism and Physical Treatment Clinic, London, SE22, The South-East London General Practitioners Centre, London, SE15".
- (11) In column (2) of the said Schedule opposite the name "St. Thomas' Hospital" in column (1) there shall be deleted the words "The General Lying-in Hospital, SE1". For the words "St. Thomas' Babies Hostel, SE11." there shall be substituted the words "The Psychiatric Day Hospital, SE11."

- (12) In column (1) of the said Schedule for the name "The Hospital for Sick Children" there shall be substituted the name "The Hospitals for Sick Children."
- (13) In column (2) of the said Schedule opposite the name "The National Hospitals for Nervous Diseases" in column (1) for the words "The Convalescent Hospital" there shall be substituted the words "The Branch Hospital".
- (14) In column (2) of the said Schedule opposite the name "The Royal National Throat, Nose and Ear Hospital" in column (1) for the words "The Royal National Throat, Nose and Ear Hospital (including the Central London Hospital Division, WC1, and the Golden Square Hospital Division, W1)" there shall be substituted the words "The Royal National Throat, Nose and Ear Hospital, Gray's Inn Road, WC1. The Royal National Throat, Nose and Ear Hospital, Golden Square, W1".
- (15) In column (2) of the said Schedule opposite the name "The Moorfields Eye Hospital" in column (1) there shall be added the words "Hospital Annexe, 15/19 View Road, Highgate, N6."
- (16) In column (2) of the said Schedule opposite the name "The Bethlem Royal Hospital and The Maudsley Hospital" in column (1) after the words "The Bethlem Royal Hospital" there shall be deleted the words "for Nervous and Mental Disorders".
- (17) In column (2) of the said Schedule opposite the name "St. John's Hospital for Diseases of the Skin" in column (1) for the words "South and Isolation Blocks of the Eastern Hospital, Homerton Grove" there shall be substituted the words "St. John's Hospital for Diseases of the Skin, Homerton Grove, E9."
- (18) In column (1) of the said Schedule for the name "The Royal National Orthopaedic Hospital" there shall be substituted the name "The Royal National Orthopaedic Hospitals". In column (2) of the said Schedule opposite the name "The Royal National Orthopaedic Hospitals" in column (1) for the words "(including the Country Branch and Convalescent Branch, Stanmore, Middlesex)" there shall be substituted the words "The Royal National Orthopaedic Hospital, Stanmore, Middlesex".
- (19) In column (1) of the said Schedule for the name "St. Peter's, St. Paul's and St. Philip's Hospitals" there shall be substituted the name "St. Peter's Hospitals." In column (2) of the said Schedule opposite the name "St. Peter's Hospitals" in column (1) for the words "St. Peter's Hospital for Stone and other Urinary Diseases, WC2" there shall be substituted the words "St. Peter's Hospital, Henrietta Street, WC2". For the words "St. Paul's Hospital for Urological and Skin Diseases, WC2" there shall be substituted the words "St. Paul's Hospital, Endell Street, WC2". After the words "St. Philip's Hospital, WC2", there shall be added the words "Shaftesbury Hospital, Shaftesbury Avenue, WC2".
- (20) In column (1) of the said Schedule for the name "Queen Charlotte's and Chelsea Hospitals" there shall be substituted the name "Queen Charlotte's Hospital for Women". In column (2) of the said Schedule opposite the name "Queen Charlotte's Hospital for Women" in column (1) for the words "including the Queen Charlotte's and Chelsea Hos-

pitals Convalescent Home, St. Leonards-on-Sea, Sussex" there shall be substituted the words "Queen Charlotte's Hospital for Women Convalescent Home, St. Leonards-on-Sea, Sussex".

- (21) In column (2) of the said Schedule opposite the name "The Eastman Dental Hospital" in column (1) there shall be deleted the words "The Eastman Dental Hospital Annexe, Guilford Place, WC1".

4. In the list of hospitals set out in the National Health Service (Constitution of Boards of Governors of Teaching Hospitals (No. 2)) Order 1948(a) as amended(b) and in the Schedule to that order for the words "The Hospital for Sick Children", "The Royal National Orthopaedic Hospital", "St. Peter's St. Paul's and St. Philip's Hospitals" and "Queen Charlotte's and Chelsea Hospitals" there shall be respectively substituted the words "The Hospitals for Sick Children", "The Royal National Orthopaedic Hospitals", "St. Peter's Hospitals" and "Queen Charlotte's Hospital for Women".

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order amends the National Health Service (Designation of London Teaching Hospitals) Order 1957:—

- (1) By deleting the Zachary Merton Convalescent Home, Northwood, Middlesex from the Group of Hospitals designated as the Royal Hospital of St. Bartholomew.
- (2) By adding the Dental Hospital, Mortimer Market, WC1 and University Hospital Annexe, 23 Devonshire Street, W1 to the Group of Hospitals designated as University College Hospital.
- (3) By removing the Arthur Stanley Institute for Rheumatic Diseases, Peto Place, NW1 from the Group of Hospitals designated as The Middlesex Hospital.
- (4) By adding the Wolfson Medical Rehabilitation Centre, SW20, to the Group of Hospitals designated as St. George's Hospital.
- (5) By removing the Westminster Hospital Chest Clinic, SW1 from the Group of Hospitals designated as Westminster Hospital.
- (6) By adding the Chepstow Lodge Pre-Convalescent Annexe, W2 to the Group of Hospitals designated as St. Mary's Hospital.
- (7) By removing the Belgrave Hospital Recovery Home, Walton-on-Thames, Surrey, the Lambeth Chest Clinic, London SE22, The Rheumatism and Physical Treatment Clinic, London SE22 and the South East London General Practitioners Centre, London SE15 from the Group of Hospitals designated as King's College Hospital.
- (8) By removing the General Lying-in Hospital, SE1 from the Group of Hospitals designated as St. Thomas' Hospital.
- (9) By changing the name of the teaching hospital known as The Hospital for Sick Children to that of The Hospitals for Sick Children.
- (10) By adding the Hospital Annexe 15/19 View Road, Highgate, N6 to the Group of Hospitals known as The Moorfields Eye Hospital.
- (11) By changing the name of the teaching hospital known as The Royal National Orthopaedic Hospital to that of the Royal National Orthopaedic Hospitals.
- (12) By changing the name of the teaching hospital known as St. Peter's, St. Paul's and St. Philip's Hospitals to that of St. Peter's Hospitals and by adding Shaftesbury Hospital, Shaftesbury Avenue, WC2, to the Group of Hospitals designated as St. Peter's Hospitals.
- (13) By changing the name of the teaching hospital known as Queen Charlotte's and Chelsea Hospitals to Queen Charlotte's Hospital for Women.
- (14) By removing the Eastman Dental Hospital Annexe, Guilford Place, WC1 from the Group of Hospitals designated as the Eastman Dental Hospital.

The Order also provides for some minor changes of name of some designated teaching hospitals.
