## CUSTOMS AND EXCISE

## The Import Duties (Quota Relief) (No. 4) Order 1974

<i>Made</i>	- - -	12th June 1974
<i>Laid before the House of Commons</i>		13th June 1974
<i>Coming into Operation</i>		14th June 1974

The Secretary of State, in exercise of the powers conferred on him by sections 5(1) and (4) and 13(1) of, and paragraph 8 of Schedule 3 to, the Import Duties Act 1958(a), as amended (b), and of all other powers enabling him in that behalf, hereby makes the following Order:

1.—(1) This Order may be cited as the Import Duties (Quota Relief) (No. 4) Order 1974 and shall come into operation on 14th June 1974.

(2) The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. Schedule 1 to the Import Duties (Quota Relief) (No. 2) Order 1973(d) shall be amended by the substitution, for the entries in columns 1, 2 and 3, of the following:—

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order, which comes into operation on 14th June 1974, extends the description of goods of the Tariff heading 48.01 that may be imported under the United Kingdom's share of a tariff quota for newsprint opened by the EEC in accordance with the provisions of the Community Instruments mentioned in Article 2. (The quota which is extended by this Order was implemented by the Import Duties (Quota Relief) (No. 2) Order 1973.)
