## The Anglian Water Authority (Mumby) Order 1974

29th August 1974 Made 16th September 1974 Coming into Operation

The Secretary of State for the Environment, in exercise of powers conferred by section 23 of the Water Act 1945(a) and now vested in him (b), and of all other powers enabling him in that behalf, hereby orders as follows:—

1.—(1) This order may be cited as the Anglian Water Authority Citation and (Mumby) Order 1974 and shall come into operation on 16th September commence-1974.

- (2) This order shall be included among the enactments which may be cited together as the Anglian Water Authority Orders 1974.
  - 2. In this order, unless the context otherwise requires— "the Authority" means the Anglian Water Authority;

Interpretation.

"the Third Schedule" means the Third Schedule to the Water Act 1945:

"the undertaking" means the water undertaking of the Authority.

3. The Authority being the owners of the land described in Schedule 2 Power to to this order, may-

construct and maintain works.

- (a) construct and maintain a borehole thereon; and
- (b) construct and maintain thereon (in addition to the works authorised by section 4 of the Third Schedule) all such wells, boreholes, adits and headworks as may be necessary or expedient for augmenting or improving the supply of water obtainable by means of the said borehole.
- 4. The works authorised by this order shall for all purposes form a Works to part of the undertaking.
- 5. For the purposes of this order the provisions of the Third Schedule Application which are set out in column 1 of Schedule 1 to this order shall, subject of certain to the modifications set out in column 2 thereof, apply to the undertaking and are hereby incorporated with this order.
