The Secretary of State, in exercise of the powers conferred on him by section 2 as read with section 11 of the Diseases of Fish Act 1937(a), and of all other powers enabling him in that behalf and having been satisfied as respects the area hereinafter mentioned that certain waters therein are infected waters, hereby makes the following order:—

Citation and commencement

1. This order may be cited as the Diseases of Fish (Infected Area) (Scotland) No. 2. Order 1974 and shall come into operation on 9th October 1974.

Interpretation

2.-(1) In this order "the area" means:-

- (a) Gateway West Fish Farm, Ford, Argyll together with the area of land and water within five hundred metres from any boundary of that fish farm and
- (b) such part of Loch Craignish, Argyll, up to the High Water Mark of Ordinary Spring Tides as lies to the east of a line drawn between Ordnance Survey Grid Reference NM810030 and NM780990 and to the south of a line drawn from Ordnance Survey Grid Reference NM810030 to that point on the mainland of the County of Argyll nearest to Ordnance Survey Grid Reference NM816026 and to the north of a line drawn from Ordnance Survey Grid Reference NM780990 to that point on the mainland of the County of Argyll nearest to Ordnance Survey Grid Reference NM792990.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

Infected Area

3. The area is hereby declared to be an infected area for the purposes of the Diseases of Fish Act 1937.

Control of Movement of Fish etc.

4. No person shall without the previous consent in writing of the Secretary of State move out of the area any live fish or eggs of fish or foodstuff for fish.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order declares Gateway West Fish Farm, Ford, Argyll together with an area of land and water adjacent to it and an area of sea in Loch Craignish, Argyll to be an infected area for the purposes of the Diseases of Fish Act 1937 and prohibits the movement out of the area of any live fish, eggs of fish or foodstuff for fish.
