FIRST SCHEDULE—Particulars of Endowments to which this Scheme relates. SECOND SCHEDULE—New Schedule to be substituted for the Seventh Schedule to the principal scheme—Prizes.

In exercise of the powers conferred on him by section 118(1) and 129 of the Education (Scotland) Act 1962(a) and section 125(5) of the said Act as substituted section 19 of the Education (Scotland) Act 1969(b) and all other powers enabling him in that behalf and after—

- (a) preparing a draft scheme to amend the Renfrewshire Educational Trust Schemes 1961 and 1965,
- (b) carrying out the procedure specified in section 125(1) of the said Act,
- (c) receiving and considering objections to the draft scheme.
- (d) framing a scheme under section 125(3) of the said Act,
- (e) carrying out the procedure specified in section 125(4) of the said Act, and
- (f) no petition or appeal having been presented to the Court of Session and no petition having been presented to him,

the Secretary of State hereby makes the following scheme:-

#### Citation

1. This scheme may be cited as the Renfrewshire Educational Trust (Amendment No. 2) Scheme 1974 and the Renfrewshire Educational Trust Schemes 1961 and 1965 and this scheme shall be construed as one and may be cited together as the Renfrewshire Educational Trust Schemes 1961 to 1974.

#### Interpretation.

2.—(1) In this scheme unless the context otherwise requires—

"governing body" means the Governors of the Renfrewshire Educational Trust;

"principal scheme" means the Renfrewshire Educational Trust Scheme 1961 approved by Her Majesty in Council on 26th May 1961 as amended by the Renfrewshire Educational Trust (Amendment No. 1) Scheme 1965 approved by Her Majesty in Council on 14th May 1965, and

"Scheme of 1936" means the Renfrewshire Educational Trust Scheme 1936, approved by His late Majesty King George VI in Council on 29th July 1937.

- (2) The Interpretation Act 1889(a) shall apply to the interpretation of this scheme as it applies to the interpretation of an Act of Parliament.
- (3) References in this scheme to any enactment or scheme shall, except where the context otherwise requires, be construed as references to that enactment or scheme as amended by or under any other enactment or scheme or as contained in any other enactment or scheme substituted for that enactment or scheme.
- (4) References in this scheme to a section, schedule, column or Part shall, except where the context otherwise requires, be construed as references to a section of or a schedule to this scheme or a column or Part of such a schedule as the case may be.

#### Augmentation of the Renfrewshire Educational Trust

- 3. From and after 4th October 1974 the following endowments shall be amalgamated with the Renfrewshire Educational Trust, that is to say:—
  - (a) the endowments named in Part I of the First Schedule, being endowments already vested in the governing body, and
  - (b) the endowments named in Part II of the First Schedule which shall be transferred to and vested in the governing body without the necessity of any new instrument or conveyance.

The said Trust as so augmented shall continue to be vested in the governing body and shall be held, administered and applied by them exclusively in accordance with the conditions and the provisions of the principal scheme as amended by this scheme. The property transferred to the governing body under this subsection shall be added to and form part of the General Fund established under section 11(1) of the Scheme of 1936.

## Transfer of cash balances, books and papers

- 4.—(1) As soon after 4th October 1974 as can conveniently be arranged the Trustees of the endowments transferred to and vested in the governing body under the provisions of section 3(b) shall transfer to the governing body all cash balances, books, deeds and papers which relate wholly or mainly to the said endowments.
- (2) The governing body shall discharge such lawful debts of the endowments transferred to and vested in the governing body under the provisions of section 3(b) as remain unpaid by the trustees or other governors of the said endowments:

Provided that the liability of the governing body to discharge the said debts shall be limited to the amount which can be realised from the assets of the said endowments and that after the accounts of the said endowments have been audited and found correct the governing body shall grant the trustees or other governors of the said endowments a discharge of their intromissions.

## Amendments to Part I of the principal scheme

- 5.—(1) In section 2(1)(i) the words "Governors of the Royal College of Science and Technology, Glasgow" shall be deleted and the words "Senate of the University of Strathclyde" shall be substituted therefor.
- (2) In section 2(1)(j) the words "Paisley Technical College" shall be deleted and the words "Paisley College of Technology" shall be substituted therefor.

## Amendments to Part III of the principal scheme

- 6. The following amendments shall be made to Part III of the principal scheme:—
- (1) in section 18(1) (which relates to the application of income) paragraphs (f) and (h) shall be deleted and the following paragraphs (f) and (h) shall be substituted respectively therefor:
  - "(f) they shall pay to the County Council the sum of £1,456, whereof;
    - (i) £194 shall be expended by the County Council in such manner as they think most beneficial to the students attending the James Watt College, Greenock, and
    - (ii) £1,262 shall be expended by the County Council on prizes in accordance with section 47;"
  - "(h) (i) they shall expend such sums as they think fit on the purposes of sections 21 and 22 (which relate to benefits for students of Paisley) provided that the aggregate of the sums so spent shall not exceed £600, and
    - (ii) they shall expend the sum of £400 on the purposes of section 23 (which relates to the John Neilson Post-Graduate Scholarships); and"
- (2) sections 21, 22 and 23 (which relate respectively to competitive senior school bursaries, competitive post-school bursaries and the most distinguished graduate prize) shall be deleted and the following sections shall be substituted therefor:—

#### "Post-school bursaries

- 21.—(1) It shall be in the power of the governing body, subject to the provisions of paragraph (h)(i) of subsection (1) of section 18 to award post-school bursaries to Protestants ordinarily resident in the area comprising the Burgh of Paisley and the Abbey Parish of Paisley. Each bursary shall be of such annual value as the governing body think fit and shall be tenable at a University, Central Institution or College of Education for such number of years as the governing body may determine.
- (2) In awarding bursaries under this section the governing body shall satisfy themselves by such means as they think fit of the attainment, merit and promise of each candidate. For this purpose they may take into account the candidate's academic record at school or other institution of further education and the results of any examination, approved by the governing body, which the candidate may have undergone."

### "Most distinguished graduates' prize

22. It shall be in the power of the governing body, subject to the provisions of paragraph (h)(i) of subsection (1) of section 18, to award each year not more than three prizes of £20 each on the recommendation of the Principal of Paisley College of Technology to the most distinguished graduates of the said College. If in the opinion of the Principal none of the graduates in any year is of sufficient distinction no awards shall be made."

#### "John Neilson Post-Graduate Scholarships

- 23. The governing body shall expend the sum of £400 in each financial year in awarding one or more post-graduate scholarships for research work or for advanced or special study to persons who are former pupils of Camphill High School, Paisley, or John Neilson High School, Paisley, or Paisley Grammar School, or failing whom, former pupils of other schools in the Burgh of Paisley and who have obtained a degree, associateship, diploma or certificate of a University or other institution of further education. provided that such persons require financial assistance to enable them to undertake such research work or advanced or special study. Each candidate shall submit for the approval of the governing body a programme of the work or study to be undertaken by him. Each scholarship shall be tenable for one year and it shall be in the power of the governing body to extend the period of tenure from year to year on being satisfied with the progress made by the holder of the scholarship. In making awards under this section the governing body shall have regard to the records of the candidates at the University or other institution of further education attended by them. The annual value of each scholarship shall be such as the governing body may fix having regard to the financial circumstances of the holder (including any other bursaries or grants paid to him) and to the expenses likely to be incurred by him."
- (3) section 27 (which relates to supplementary bursaries for students attending Universities, Central Institutions, etc) shall be deleted and the following section shall be substituted therefor:—

## "Bursaries for higher education

- 27. Where provision is made in Part I of the approved plan for expenditure under this section, the governing body may in each financial year expend a sum not exceeding the maximum sum so provided in awarding bursaries of such annual value as they think fit to persons belonging to the County who are about to enter or are in attendance at a University or any institution of further education or who are about to register or have registered for Open University courses. In selecting bursars from among applicants who are about to enter or register with the said establishments, the governing body shall have regard to the school records, personal qualities and promise of the applicants, and to the results of any general bursary competition in which the applicants, or any of them, may have competed. In selecting bursars from among applicants who are in attendance at any of the said establishments, the governing body shall have regard to the records of the applicants in their respective courses of study. Each bursary shall be tenable for one year, and it shall be in the power of the governing body to extend the period of tenure from year to year on being satisfied with the progress made by the holder of the bursary."
- (4) The following section shall be inserted in Part III of the principal scheme after section 27 thereof as substituted under the immediately preceding subsection (3):—

## "Grants for second or subsequent degrees

27A. The governing body may make grants to persons belonging to the County who have obtained a degree, associateship, diploma or certificate of a University or other institution of further education to enable them to obtain a second degree, associateship or other qualification. The said grants shall be awarded only to such of the said persons as satisfy the governing body that they will genuinely benefit from a further course of study and that they are in such financial circumstances as to require aid in undertaking such further

courses. In determining the amount of each grant the governing body shall have regard to the financial circumstances of the applicant."

- (5) in section 40 (which relates to preferences for certain beneficiaries) the following amendments shall be made:—
  - (a) in lines 2 and 3 of section 40(1) the words "or foundationers at the John Neilson Institution" shall be deleted;
  - (b) in line 12 of section 40(1) "14" shall be deleted and "13" shall be substituted therefor;
  - (c) in line 2 of section 40(2) "23" shall be deleted;
  - (d) in line 4 of section 40(2) "13" shall be deleted and "12" shall be substituted therefor, and
  - (e) in line 6 of section 40(2) after "(h)" there shall be inserted "(i)".
- (6) Section 43 (which relates to the limitation of value of awards) shall be deleted and the following section shall be substituted therefor:—

#### "Limitation of value of awards

43. The value of any award made under this scheme to a person who holds or is to hold a bursary, scholarship or grant which is paid out of moneys provided by Parliament or out of any fund aided by grants from Parliament shall not be such as will cause the said bursary, scholarship or grant to be reduced."

## Amendments to Part IV of the principal scheme

- 7. The following amendments shall be made to Part IV of the principal scheme:—
  - (1) section 46 (which relates to foundations at John Neilson Institution) shall be deleted, and
  - (2) section 47 (which relates to prizes) shall be deleted and the following section shall be substituted therefor:—

#### "Prizes

- 47.—(1) The County Council shall expend the sum of £1,262 to be paid to them under section 18(1)(f)(ii) in awarding annually the prizes described in the Seventh Schedule. The number of prizes to be awarded annually, the sum to be expended annually, the beneficiaries and special conditions of a specific prize shall be as stated in columns (3), (4) and (5) respectively opposite to the name of that prize in column (2) of the said Schedule, provided that where no number is stated the County Council shall determine the number to be awarded.
- (2) If any school mentioned in column (5) of the said Schedule is discontinued in whole or in part, it shall be in the power of the County Council to award prizes attached thereto to pupils attending the school or schools to which the majority of the pupils formerly attending the school or part of the school which has been discontinued were transferred.
- (3) It shall be in the power of the County Council to decide the particular form a prize shall take.
- (4) In awarding a prize to the pupils of any school the County Council shall have regard to the views of the head teacher of that school, who before submitting his views shall consult the teachers concerned.

- (5) If the award of prizes is discontinued in any school mentioned in column (5) of the said Schedule it shall be in the power of the County Council to expend the sum stated in column (4) opposite to the name of the prize in column (2) of the said Schedule on the promotion of a project of an educational nature in that school. Such sums shall be additional to funds which the County Council as Education Authority may reasonably be expected to provide. Wherever possible the project should be allied to the subject or department mentioned in column (6) opposite to the name of the prize in column (2) of the said Schedule.
- (6) If at the end of any financial year of the County Council there is an unexpended balance of the sum received for the purposes of this section, the County Council shall carry the said balance forward to the following financial year, provided that it shall be in the power of the County Council to expend the said balance or part thereof under such conditions as they think fit in awarding additional prizes to pupils attending public schools in the County or in promoting projects of an educational nature in the said schools, or, if in their opinion any of the sums set forth in column (4) of the Seventh Schedule is inadequate, in increasing the said sum by such amount as they consider necessary."

## Amendments to Third Schedule to the principal scheme

8.—(1) The following amendment shall be made to the Third Schedule to the principal scheme:—

in column (2) opposite to serial number 1 the words "Paisley Technical College" shall be deleted and the words "Paisley College of Technology" shall be substituted therefor.

- (2) The following entries shall be inserted in the Third Schedule to the principal scheme:—
  - "3A The governing body shall each year pay to the Headmistress of Glenburn School, Greenock, the sum of £3 to be expended in such manner as she thinks most beneficial in the interests of the pupils attending the said school."
  - "3B The governing body shall each year pay to the Headmistress of Glenburn School the sum of £25.80 to be expended by her in purchasing clothes and shoes for necessitous pupils attending the said school who have been recommended for a holiday by the County Medical Officer."
  - "5 The governing body shall each year pay to the Principal of the James Watt College the sum of £32.50 to be expended by him in such manner as he thinks most beneficial in the interests of the students attending the said College."
  - "6 The governing body shall each year pay to the Head Teacher of Williamsburgh Primary School the sum of £6.75 to be expended by her in purchasing books for the library of the said school."
  - "7 The governing body shall each year pay to the County Council the sum of £27 to be expended by them in purchasing from time to time for schools in Paisley, sheet music required for festival purposes or in giving a grant towards the travelling expenses of pupils attending schools in Paisley who are taking part in a recognised musical festival."
  - "8 The governing body shall each year pay to the County Council the sum of £27.50 to be expended by them in awarding grants to pupils who are attending schools in the County and who require financial assistance to enable them to attend a school camp."

"9 The governing body shall each year pay to the County Council the sum of £3 to be expended by them in awarding grants to pupils who are attending schools in District No 4 and who require financial assistance to enable them to to attend a school camp."

#### Amendments to Fourth Schedule to the principal scheme

- 9. The following amendments shall be made to the Fourth Schedule to the principal scheme:—
  - (1) in column (4) opposite to serial number 3 "Scottish Leaving Certificate" shall be deleted and "Scottish Certificate of Education" shall be substituted therefor:
  - (2) in column (4) opposite to serial number 5 "Mount Junior Secondary School, Greenock" shall be deleted and "Cowdenknowes High School, Greenock" shall be substituted therefor, and
  - (3) in column (4) opposite to serial number 6 "John Neilson Institution, Camphill Senior Secondary School and the Paisley Grammar School and William B Barbour Academy" shall be deleted and "John Neilson High School, Camphill High School and Paisley Grammar School" shall be substituted therefor.

#### Amendments to Fifth Schedule to the principal scheme

- 10. The following amendments shall be made to the Fifth Schedule to the principal scheme:—
  - (1) in column (2) opposite to number of section 27 "Supplementary bursaries for students attending Universities, Central Institutions, etc" shall be deleted and "Bursaries for higher education" shall be substituted therefor, and
  - (2) after the entry for number of section 27 the following entry shall be inserted:—
    - "27A Grants for second or subsequent degrees."

#### Amendments to Sixth Schedule to the principal scheme

- 11. The following amendments shall be made to the Sixth Schedule to the principal scheme:—
  - (1) in column (2) opposite to serial number 1 "Senior Secondary" shall be deleted and "High" substituted therefor;
  - (2) in column (2) opposite to serial number 8 "Institution" shall be deleted and "High School" substituted therefor, in column (3) "£135" shall be deleted and "£195" shall be substituted therefor and in column (4) there shall be inserted "Paisley Educational Trust";
  - (3) in column (1) serial number "9" and the opposing entries in columns (2), (3) and (4) shall be deleted;
  - (4) in column (1) serial numbers "10" to "15" shall be renumbered "9" to "14";
  - (5) in column (3) opposite to serial number 10 "£20" shall be deleted and "£32" shall be substituted therefor and in column (4) there shall be inserted "Adam Buchanan Bequest", and
  - (6) in column (2) opposite to serial number 13 "and William B Barbour Academy" shall be deleted.

#### Amendment of the Seventh Schedule to the principal scheme

12. The entries in columns (1) to (6) inclusive of the Seventh Schedule to the principal scheme shall be deleted and the entries in columns (1) to (6) inclusive of the Second Schedule to this scheme shall be substituted therefor.

#### Revocation

13. The provisions of section 22 of the Royal College of Science and Technology, Glasgow, Scheme, 1962 (which relate to the transfer of part of the Clyde Training Ship "Empress" Trust to the governing body) shall cease to have effect on 4th October 1974.

#### Copies of scheme

14. The governing body shall maintain a supply of printed copies of this scheme and shall cause a copy to be kept available for inspection by every member or officer of the governing body and copies shall be available for sale at a reasonable price.
