Perth and Kinross Educational Trust (Amendment) Scheme 1974

In exercise of the powers conferred on him by section 118(1) and 129 of the Education (Scotland) Act 1962(a) and section 125(2) of the said Act as substituted by section 19 of the Education (Scotland) Act 1969(b) and all other powers enabling him in that behalf and after—

- (a) preparing a draft scheme to amend the Perth and Kinross Educational Trust Scheme 1964
- (b) carrying out the procedure specified in section 125(1) of the said Act, and
- (c) no objections or proposed amendments to the draft scheme having been received by him,

the Secretary of State hereby makes the following scheme:-

Citation

1. This scheme may be cited as the Perth and Kinross Educational Trust (Amendment) Scheme 1974 and the principal scheme and this scheme shall be construed as one and may be cited as the Perth and Kinross Educational Trust Schemes 1964 and 1974.

Interpretation

- 2.—(1) In this scheme unless the context otherwise requires:—
- "principal scheme" means the Perth and Kinross Educational Trust Scheme, 1964.
- (2) The Interpretation Act 1889(c) applies for the interpretation of this scheme as it applies for the interpretation of an Act of Parliament.
- (3) References in this scheme to any enactment or scheme shall, except where the context otherwise requires, be construed as references to that enactment or scheme as amended by or under any other enactment or scheme or as contained in any other enactment or scheme substituted for that enactment or scheme.
- (4) References in this scheme to a section, schedule or column shall, except where the context otherwise requires, be construed as references to a section of or a schedule to this scheme or a column of such a schedule as the case may be.

Augmentation of the Perth and Kinross Educational Trust

3. From and after 3rd October 1974, the endowments specified in Schedule 1 to this scheme shall be vested in the County Council and shall be amalgamated with the Perth and Kinross Educational Trust to be held, administered and applied exclusively in accordance with the provisions of the principal scheme as amended by this scheme.

Amendments to sections of the principal scheme

- 4. The undernoted sections of the principal scheme shall be changed as follows:—
 - (a) In subsection (3) of section 18 of the principal scheme, for the figure of "£1,000" substitute "£2,000".
 - (b) The following subsection shall be inserted after subsection (4) of section 47 of the principal scheme:—
 - "(5) If the award of prizes is discontinued in any school mentioned in column (5) of the said Schedule, it shall be in the power of the County Council to expend the sum stated in column (4) opposite the name of the prize in column (2) of the said Schedule on the promotion of projects of an educational nature in, or for the benefit of the pupils attending, that school. Such sums shall be additional to funds which the County Council as Education Authority may reasonably be expected to provide. Wherever possible the projects should be allied to the subject or department shown in column (6) of the Schedule."
 - (c) Section 51 of the principal scheme shall be deleted.
