# The North West Water Authority (Fylde Water Supply Unit) (Boreholes) Order 1974

Made

21st November 1974

Coming into Operation

9th December 1974

The Secretary of State for the Environment, in exercise of the powers conferred by sections 23 and 33 of the Water Act 1945(a) now vested in him(b) and of all other powers enabling him in that behalf, hereby orders as follows:-

1.—(1) This order may be cited as the North West Water Authority Citation and (Fylde Water Supply Unit) (Boreholes) Order 1974 and shall come into commenceoperation on 9th December 1974.

- (2) This order shall be included among the enactments which may be cited together as the North West Water Authority Orders 1974.
  - 2. In this order, unless the context otherwise requires—

Interpreta-

- "the Authority" means the North West Water Authority:
- "the Third Schedule" means the Third Schedule to the Water Act

"the undertaking" means the undertaking of the Authority as for the time being authorised by any enactment.

3. The Authority may continue and maintain the existing boreholes Construction constructed on or under the lands described in Schedule 1 to this order and conand may construct and maintain on or under such lands (in addition to works the works authorised by section 4 of the Third Schedule as applied to the undertaking by this order) all such pumping stations, wells, boreholes, adits and headings as may be necessary or expedient for augmenting or improving the supply of water obtainable by means of the said boreholes.

4. The works authorised by this order shall for all purposes be deemed Works to to form part of the undertaking.

5. For the purposes of this order the provisions of the Third Schedule Application which are specified in column (1) of Schedule 2 to this order shall, subject of certain to the modifications set out in column (2) thereof, apply to the undertaking provisions and are hereby incorporated with this order.
