The Ancillary Dental Workers (Amendment) Regulations 1974

Laid before Parliament in draft

Made - - - 19th March 1974

Coming into Operation 1st May 1974

The General Dental Council in exercise of the powers conferred upon them by section 41 of the Dentists Act 1957(a) and of all other powers enabling them in that behalf hereby make the following regulations:

- 1. These regulations may be cited as the Ancillary Dental Workers (Amendment) Regulations 1974 and shall come into force on 1st May 1974.
- 2. The Ancillary Dental Workers Regulations 1968(b) shall be amended as follows:
 - (1) In paragraphs (1) and (3) of regulation 4 for the word "March" wherever it appears there shall be substituted the word "December".
 - (2) In paragraph (2) of regulation 4 for the words "fourteenth day of March" there shall be substituted the words "first day of December".
 - (3) For regulation 6 there shall be substituted the following:

"Fees Payable for Enrolments, etc.

6. The following are the fees prescribed by the Council under subsection (7) of section 41 of the Act:

For first enrolment of a name £2

For the retention of a name under regulation 4 of these regulations £1.50

For restoration of a name under regulation 5 of these regulations £1 ,

(4) For regulation 23(1)(c) there shall be substituted the following:

"(c) the application to the teeth of such prophylactic materials as the Council may from time to time determine;"

(5) For regulation 28(1)(e) there shall be substituted the following:

"(e) the application to the teeth of such prophylactic materials as the

Council may from time to time determine;"

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Ancillary Dental Workers Regulations 1968 as follows:

The fee for the retention of a name in a Roll is increased from £1 to £1.50. The date by which the fee must be paid for the next following year is amended from 31st March to 31st December. The coming into operation of the amending Regulations has been postponed until 1st May 1974, so that the fee to be paid for retention in the Rolls for the period 31st March to 31st December 1974 is £1.

The definition of the material which may be applied to the teeth by dental hygienists and dental auxiliaries for the prevention of dental disease has been widened to permit the use of such prophylactic materials as the General Dental Council may from time to time determine.

The Regulations were approved in draft:—

- (a) by the Privy Council on the 9th day of November 1973.
- (b) by a resolution of the House of Lords on the 8th day of February 1974.
- (c) by a resolution of the House of Commons on the 8th day of February 1974.
