The Assistance for House Purchase and Improvement (Housing Associations) (Amendment) Regulations 1975

The Secretary of State for the Environment, the Secretary of State for Wales and the Secretary of State for Scotland, acting jointly in exercise of their powers under sections 26(4) and 32(2) of the Housing Subsidies Act 1967(a)(b) and of all other powers enabling them in that behalf, hereby make the following regulations:—

- 1.—(1) These regulations may be cited as the Assistance for House Purchase and Improvement (Housing Associations) (Amendment) Regulations 1975 and shall come into operation on 1st September 1975.
- (2) The Interpretation Act 1889(c) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.
- 2. The Assistance for House Purchase and Improvement (Housing Associations) Regulations 1968(d), as amended by the Assistance for House Purchase and Improvement (Housing Associations) (Amendment) Regulations 1971(e), shall be further amended in accordance with the Schedule to these regulations.

SCHEDULE

AMENDMENTS TO THE 1968 REGULATIONS

- 1. In regulation 2—
 - (a) in paragraph (2) for the words "section 43 of the Finance Act 1963" substitute the words "section 341 of the Income and Corporation Taxes Act 1970"; and
 - (b) after paragraph (2) add the following paragraph—

(b) The powers conferred upon the Minister for Housing and Local Government are now exerciseable by the Secretary of State for the Environment under S.I. 1970/1681 (1970 III. p. 5551).

- "(3) References in these regulations to any enactment shall, unless the context otherwise requires, be construed as references to that enactment as amended, and as including references thereto as applied by or under any enactment.".
- 2. In paragraph 1 of the Schedule—
 - (a) in sub-paragraph (f) for the words "paragraphs (a), (b) and (c)" substitute the words "paragraphs (a), (b), (c) and (d)";
 - (b) in sub-paragraph (g)—
 - (i) after the word "and" where first occurring insert the words "paragraphs (vii), (ix), (x), and (xi) of subsection (3) shall not apply, but otherwise"; and
 - (ii) omit the word "and" where second occurring; and
 - (c) at the end of sub-paragraph (h) add the following words—
 - "and;
 - (i) subsection (5A) shall not apply.".
- 3. For paragraph 2 of the Schedule substitute the following paragraph—
- "2. Sections 24A, 24B, 25 and 26 (with the exception of subsections (4) and (6)) shall not apply.".
- 4. In paragraph 4 of the Schedule omit the words from "with the addition" to the end of that paragraph.
 - 5. After paragraph 4 of the Schedule add the following paragraph—"4A. Section 28A shall not apply.".
 - 6. Omit paragraph 6 of the Schedule.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Assistance for House Purchase and Improvement (Housing Associations) Regulations 1968, which made certain adaptations and modifications to Part II of the Housing Subsidies Act 1967 (which deals with option mortgage subsidy) in its application to housing associations, to take account of various amendments to the 1967 Act and, in particular, those made by section 119(1) of, and Schedule 11 to, the Housing Act 1974 (c. 44).
