**The Wages Regulation (Retail Drapery, Outfitting and
Footwear) (Amendment) Order 1975**

Made - - - - 12th February 1975

Coming into Operation 17th March 1975

Whereas the Secretary of State has received from the Retail Drapery, Outfitting and Footwear Trades Wages Council (Great Britain) the wages regulation proposals set out in the Schedule hereto;

Now, therefore, the Secretary of State in exercise of powers conferred by section 11 of the Wages Councils Act 1959(a), and now vested in him(b), and of all other powers enabling him in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Wages Regulation (Retail Drapery, Outfitting and Footwear) (Amendment) Order 1975.

2.—(1) In this Order the expression “the specified date” means the 17th March 1975, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression “the specified date” means, as respects that worker, the beginning of the next such period following that date.

(2) The Interpretation Act 1889(c) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The wages regulation proposals set out in the Schedule hereto shall have effect as from the specified date.

SCHEDULE

The Wages Regulation (Retail Drapery, Outfitting and Footwear) Order 1974(a) (Order R.D.O. (66)) shall have effect as if in the Schedule thereto for paragraph 2 there were substituted the following paragraph:—

“COST OF LIVING PAYMENT

2.—(1) In addition to the minimum remuneration specified in paragraph 1 of this Schedule, additional remuneration, hereinafter referred to as the ‘cost of living payment’, shall, in accordance with this paragraph, be payable to all workers to whom that paragraph applies.

(2) The cost of living payment payable in respect of each complete pay week shall be:—

- (a) £4.40 per week in the case of a full-time worker as defined in paragraph 21 of this Schedule;*
- (b) 11p multiplied by the number of hours normally worked by him in a week in the case of a worker to whom proviso (a) to paragraph 11(3) of this Schedule applies;*
- (c) 11p multiplied by the number of hours worked (excluding overtime) by him in the relevant week in the case of a worker other than a worker to whom (a) or (b) of this sub-paragraph applies;*

(3) The cost of living payment shall not be treated as part of the minimum weekly remuneration for the purpose of calculating payment for overtime under paragraph 8 of this Schedule.”

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which has effect from 17th March 1975, amends the Wages Regulation (Retail Drapery, Outfitting and Footwear) Order 1974 (Order R.D.O. (66)) by providing for an increase in the cost of living payment.
