#### **TEINDS**

#### Act of Sederunt (Fees in Court of Teinds) 1975

Made - - - - 11th November 1975 Coming into Operation 8th December 1975

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 2 of the Courts of Law Fees (Scotland) Act 1895(a) and section 11(3) of the Church of Scotland (Property and Endowments) Act 1925(b) and of all other powers competent to them in that behalf, do hereby, with the approval of the Treasury, enact and declare:—

- 1. The Act of Sederunt (Fees in the Court of Teinds) 1971(c) is revoked.
- 2. The fees specified in the right hand column of the Schedule to this Act are the fees payable to the Clerk of Teinds in respect of the matters specified opposite them in the left hand column of the Schedule.
- 3. This Act of Sederunt may be cited as the Act of Sederunt (Fees in the Court of Teinds) 1975, and shall come into operation on 8th December 1975.
