The European Communities (Definition of Treaties) Order 1975

Laid before Parliament in draft

18th March 1975 Made -

Coming into Operation in accordance with Article 1

At the Court at Buckingham Palace, the 18th day of March 1975 Present.

The Queen's Most Excellent Majesty in Council

Whereas a draft of this Order has been laid before Parliament in accordance with section 1 of the European Communities Act 1972(a) and has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty, by virtue and in exercise of the powers conferred on Her by section 1(3) of the European Communities Act 1972 or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1. This Order may be cited as the European Communities (Definition of Treaties) Order 1975. It shall come into operation in respect of each treaty specified in Part I of the Schedule to this Order on the date on which the Order is made. In respect of each treaty specified in Part II of the Schedule to this Order, the Order shall come into operation on the date on which the treaty enters into force for the United Kingdom, which date will be notified in the London, Edinburgh and Belfast Gazettes.
- 2. The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The treaties specified in the Schedule to this Order are to be regarded as Community Treaties as defined in section 1(2) of the European Communities Act 1972.
