**The Immigration (Particulars of Passengers and Crew)
(Amendment) Order 1975**

Made - - - - - *7th June 1975*
Coming into Operation *1st September 1975*

In exercise of the powers conferred upon me by paragraph 27(2) of Schedule 2 to the Immigration Act 1971(a), I hereby make the following Order:—

1. This Order may be cited as the Immigration (Particulars of Passengers and Crew) (Amendment) Order 1975 and shall come into operation on 1st September 1975.
2. For the form set out in the Schedule to the Immigration (Particulars of Passengers and Crew) Order 1972(b) there shall be substituted the form set out in the Schedule to this Order.
3. Notwithstanding Article 2 of this Order, during the period of one year following the coming into operation of this Order the master of a ship who is required to furnish a return under Article 3(2)(b)(i) of the said Order of 1972 may do so in the form set out in the Schedule to that order as originally enacted.

EXPLANATORY NOTE

(This Note is not part of the Order.)

Article 3 of the Immigration (Particulars of Passengers and Crew) Order 1972 requires (inter alia) the master of a ship arriving in the United Kingdom from or after calling at a place outside the common travel area to furnish to an immigration officer within 12 hours a return containing particulars of all crew members, the form of return being prescribed in the Schedule to the Order. This Order, as from 1st September 1975, substitutes a new form recommended for this purpose by the United Nations Inter-Governmental Maritime Consultative Organisation, while allowing the old form to be used as an alternative for one year after that date.
