CUSTOMS AND EXCISE

The Import Duties (General) (No. 4) Order 1976

Made - - - - - 28th June 1976

Laid before the House of Commons 29th June 1976

Coming into Operation - - - 1st July 1976

The Lords Commissioners of Her Majesty's Treasury, by virtue of the powers conferred on them by sections 1, 3(6) and 13 of the Import Duties Act 1958(a), as amended by section 5(5) of, and paragraph 1 of Schedule 4 to, the European Communities Act 1972(b), and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State(c), hereby make the following Order:—

1.—(1) This Order may be cited as the Import Duties (General) (No. 4) Order 1976 and shall come into operation on 1st July 1976.

(2) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. The Import Duties (General) (No. 5) Order 1975(e), as amended(f), shall be further amended as follows:—

(a) After Article 6(6) there shall be inserted:

“(7) In the case of goods of Iceland which fall within a heading or sub-heading specified in column 1 of Part VI of Schedule 3 hereto and, where a description is specified in column 2 thereof, are of that description, import duty shall be charged at the rate, if any, specified in relation to the goods in column 3 thereof.”

(b) After Part V in Schedule 3 there shall be inserted Part VI as specified in the Schedule hereto.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 1st July 1976, implements obligations of the United Kingdom under Protocol 6 to the Agreement between the European Economic Community and Iceland concerning the special provisions applicable to imports of certain fish products.

The Order amends the Import Duties (General) (No. 5) Order 1975 by providing for reduced rates of import duty in the case of the goods of Iceland in question.
