The Northern Ireland (Various Emergency Provisions) (Continuance) Order 1976

Laid before Parliament in draft

Made - - - 7th July 1976 Coming into Operation 25th July 1976

Whereas a draft of this Order has been approved by a resolution of each House of Parliament:

Now, therefore, I, the Right Honourable Merlyn Rees, one of Her Majesty's Principal Secretaries of State, in pursuance of section 30(3)(a) of the Northern Ireland (Emergency Provisions) Act 1973(a), section 3(2)(a) of the Northern Ireland (Young Persons) Act 1974(b) and section 21(3)(a) of the Northern Ireland (Emergency Provisions) (Amendment) Act 1975(c), as amended in the case of the said sections 30(3)(a) and 3(2)(a) by section 22(3) of the last-mentioned Act, and of all other powers enabling me in that behalf, hereby order as follows:—

- 1. This Order may be cited as the Northern Ireland (Various Emergency Provisions) (Continuance) Order 1976 and shall come into operation on 25th July 1976.
 - 2.—(1) In this Order, the expression "the temporary provisions" means—
 - (a) sections 2, 3, 4, 6, 7, 8, 10 to 21, 23 and 24 of and Schedules 2, 3 and 4 to the Northern Ireland (Emergency Provisions) Act 1973;
 - (h) section 1 of the Northern Ireland (Young Persons) Act 1974; and
 - (c) sections 2, 5, 9, 11, 15 and 16 of and Schedule 1 to the Northern Ireland (Emergency Provisions) (Amendment) Act 1975.
- (2) Any reference in this Order to an enactment is a reference to that enactment as for the time being amended by or under any enactment.
- (3) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. The temporary provisions shall continue in force for a period of 6 months beginning with 25th July 1976.

EXPLANATORY NOTE

This Order continues in force for six months from 25th July 1976 all the temporary provisions of the Northern Ireland (Emergency Provisions) Act 1973, the Northern Ireland (Young Persons) Act 1974 and the Northern Ireland (Emergency Provisions) (Amendment) Act 1975.
