SEEDS

The Seeds (Fees) Regulations 1976

Made - - 24th August 1976

Laid before Parliament 3rd September 1976

Coming into Operation 24th September 1976

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland, acting jointly, in exercise of the powers vested in them by section 16(1A)(e) and (8) of the Plant Varieties and Seeds Act 1964 (a), as amended by section 4(1) of and paragraph 5(1), (2) and (3) of Schedule 4 to the European Communities Act 1972 (b), and of all other powers enabling them in that behalf, after consultation with representatives of such interests as appear to them to be concerned, hereby make the following regulations:—

Citation and commencement

1. These regulations may be cited as the Seeds (Fees) Regulations 1976 and shall come into operation on 24th September 1976.

Revocation of previous regulations

2. The Seeds (Fees) (No. 2) Regulations 1975 (c) are hereby revoked.

Interpretation

3. The Interpretation Act 1889(d) shall apply to the interpretation of these regulations as it applies to the interpretation of an Act of Parliament and as if these regulations and the regulations hereby revoked were Acts of Parliament.

Fees

- 4. There shall be paid in respect of matters arising under the regulations referred to in the Schedules to these regulations or under any regulations amending or superseding the regulations so referred to the fees respectively specified in the second column of each of the said Schedules opposite the references to such matters.
- 5.—(1) Subject to paragraph (2) of this regulation any such fees in respect of matters arising in England and Wales shall be payable to the Minister of Agriculture, Fisheries and Food (hereinafter referred to as "the Minister") and any such fees in respect of matters arising in Scotland shall be payable to the Secretary of State.

(2) Where the inspection of a crop is undertaken by a licensed crop inspector, where the sampling of a seed lot is undertaken by a licensed seed sampler and where the testing of a sample of seeds is undertaken by a licensed seed testing station the fee for such inspection, sampling and testing shall be payable to the licensed crop inspector, the licensed seed sampler or the licensed seed testing station concerned.

They prescribe fees in respect of matters arising under the Cereal Seeds Regulations 1976, the Fodder Plant Seeds Regulations 1976, the Beet Seeds Regulations 1976, the Oil and Fibre Plant Seeds Regulations 1976, the Vegetable Seeds Regulations 1975 and the Seeds (Registration and Licensing) Regulations 1974, or any regulations amending or superseding any of those regulations.
