**WATER, ENGLAND AND WALES**

**The Yorkshire Water Authority (Grimwith Reservoir Local Enactments) Order 1976**

*Made* - - - - 19th October 1976

*Coming into Operation* 1st November 1976

The Secretary of State for the Environment, in exercise of powers conferred by sections 23 and 50 of the Water Act 1945(a) and now vested in him (b) and of all other powers enabling him in that behalf hereby orders as follows:—

1.—(1) This order may be cited as the Yorkshire Water Authority (Grimwith Reservoir Local Enactments) Order 1976, and shall come into operation on 1st November 1976. Citation and commencement.

(2) This order shall be included among the enactments which may be cited together as the Yorkshire Water Authority Orders 1974 to 1976.

2. The Yorkshire Water Authority (Grimwith Reservoir) Order 1974(c) is hereby amended by inserting at the end of Schedule 3 thereto the additional items set out in the Schedule to this Order. Repeal of enactments.

3. For the purposes of this order, section 94 of the Third Schedule to the Water Act 1945 (which requires undertakers to keep a copy of the special Act at their principal offices and to deposit copies with certain officers) shall apply to the undertaking of the Yorkshire Water Authority and is hereby incorporated with this order. Section 94 of Third Schedule to Water Act 1945 applied.
