# TELEVISION AND LOCAL SOUND BROADCASTING

# The Independent Broadcasting Authority Act 1973 (Isle of Man) Order 1976

Made -27th October 1976 27th October 1976 Coming into Operation

At the Court at Buckingham Palace, the 27th day of October 1976. Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 40(3) (read with section 39(2) and (3)) of the Independent Broadcasting Authority Act 1973(a), section 4(3) of the Independent Broadcasting Authority Act 1974(b) and section 2(3) of the Independent Broadcasting Authority (No. 2) Act 1974(c) is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:-

- 1. This Order may be cited as the Independent Broadcasting Authority Act 1973 (Isle of Man) Order 1976.
- 2. The Television Act 1964 (Isle of Man) Order 1965(d), the Television Act 1964 (Isle of Man) Order 1969(e) and the Sound Broadcasting Act 1972 (Isle of Man) Order 1973(f) are hereby revoked.
- 3. The Interpretation Act 1889(g) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 4. The provisions of the Independent Broadcasting Authority Act 1973, as amended by the Independent Broadcasting Authority Act 1974 and the Independent Broadcasting Authority (No. 2) Act 1974, shall extend to the Isle of Man subject to the adaptations and modifications specified in the Schedule to. this Order and any reference in the Schedule to that Act shall be to that Act as amended.

### **SCHEDULE**

Adaptations and Modifications in the Extension of the Independent Broadcasting Authority Act 1973 to the Isle of Man

- 1. Unless the context otherwise requires, any reference to the Independent Broadcasting Authority Act 1973 or to any other Act of Parliament which has been extended to the Isle of Man shall be construed as a reference to that Act as so extended.
- 2. Any reference in the Independent Broadcasting Authority Act 1973 to local sound broadcasting shall be construed as a reference only to local sound broadcasting provided by the Independent Broadcasting Authority in the United Kingdom by virtue of the said Act, as it has effect in the United Kingdom.
- 3. For any reference to the Minister there shall be substituted a reference to the Secretary of State.
  - 4. After section 2(4) there shall be inserted the following provision:—
  - "(5) Nothing in this section shall be construed as authorising the Authority to provide any local sound broadcasting station for the Isle of Man.".
  - 5. After section 3(7) there shall be inserted the following provision:—
  - "(8) Nothing in this section shall be construed as authorising the Authority to establish, install or use any wireless telegraphy station in the Isle of Man as a local sound broadcasting station.".
  - 6. In section 4(6) the words following "cinematograph film" shall be omitted.
  - 7. After section 8(9) there shall be inserted the following provision:—
  - "(10) In relation to any television broadcasting station in the Isle of Man, the reference in subsection (7)(e) of this section to a Minister of the Crown shall include a reference to the Lieutenant Governor of the Isle of Man.".
  - 8. For section 16(3) there shall be substituted the following subsection:—
  - "(3) In relation to employment in the Isle of Man, the references in this section to the House of Commons, Government departments, the Secretary of State and the Industrial Arbitration Board shall be construed as references to Tynwald, Boards of Tynwald, Statutory Boards, Departments of the Isle of Man Government, the Lieutenant Governor of the Isle of Man and a board of arbitration established under section 3 of the Trade Disputes Act 1936 (an Act of Tynwald), so however that for the purposes of the last mentioned section as applied by this section the words "and if both parties consent" shall be omitted, and that if either party fails to make a nomination to the board the Lieutenant Governor may make that nomination."
  - 9. Section 22(6) shall be omitted.
  - 10. For section 22(8) there shall be substituted the following provision:—
  - "(8) In relation to any television broadcasting station in the Isle of Man, the reference in subsection (1) of this section to a Minister of the Crown shall include a reference to the Lieutenant Governor of the Isle of Man.".
  - 11. For section 26 there shall be substituted the following section:—
  - "26. The contracts between the Authority and the various programme contractors shall provide for payments to be made by the programme contractors to the Authority representing what appear to the Authority to be the appropriate contributions of the respective programme contractors towards meeting the sums which the Authority regard as necessary in order to discharge their duty under section 25(2) of this Act.".

- 12. Sections 27, 27A and 27B shall be omitted.
- 13. For section 32(3) there shall be substituted the following subsection:—
- "(3) In relation to any agreement affecting employment in the Isle of Man the reference in subsection (2) of this section to the Secretary of State shall include a reference to the Lieutenant Governor of the Isle of Man.".
- 14. In section 37(1) the definition of "the Minister" shall be omitted.
- 15. In section 40, subsections (2), (3) and (4) shall be omitted.
- 16. In Schedule 2A in paragraph 8 in the definition of "additional payments" for the words "this Act" there shall be substituted the words "the Independent Broadcasting Authority Act 1973 as it has effect in the United Kingdom".

# **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order extends the Independent Broadcasting Authority Act 1973 as amended to the Isle of Man with adaptations and modifications, one of the effects of which is to exclude the provision of local sound broadcasting under the Act in the Isle of Man. The Orders in Council which extended the Acts consolidated in the Act of 1973 are revoked.
