PRISONS

The Prison (Scotland) Amendment Rules 1976

Laid before Parliament in Draft

Made - - - - 9th November 1976

Coming into Operation 22nd November 1976

In exercise of the powers conferred on me by section 35 of the Prisons (Scotland) Act 1952^(a), and of all other powers enabling me in that behalf, I hereby make the following rules, a draft of which has been laid before Parliament:—

Title and commencement

1. These rules may be cited as the Prison (Scotland) Amendment Rules 1976 and shall come into operation on 22nd November 1976.

Interpretation

2.—(1) The Interpretation Act 1889^(b) shall apply for the interpretation of these rules as it applies for the interpretation of an Act of Parliament.

(2) In these rules the expression “the principal rules” means the Prison (Scotland) Rules 1952^(c) as amended^(d).

Amendment of Principal Rules

3. For Rule 9 of the principal rules there shall be substituted the following Rule:—

“9. The prisons specified in the first column of the subjoined table shall be legal places of detention for all classes of prisoners, and shall be prisons to which prisoners from the local authority areas specified opposite each prison in the second column of the table may lawfully be committed.
